Thursday, April 3, 2014

The House of Representatives of the Twenty-Seventh Legislature of the State of Hawaii, Regular Session of 2014, convened at 12:10 o'clock p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by The Reverend John R. Heidel of United Church of Christ, after which the Roll was called showing all Members present with the exception of Representatives Carroll and Say, who were excused.

The House of Representatives reconvened at 12:44 o'clock p.m.

ORDER OF THE DAY

SUSPENSION OF RULES

At this time, the Chair stated:

"Members, please note that House Resolution No. 87, House Draft 1, and House Concurrent Resolution No. 122, House Draft 1, have been re-referred solely to the Committee on Health per Committee Referral Sheet No. 49. The Committees on Consumer Protection & Commerce and Finance waived their referral to these measures, and therefore it is appropriate for the House to consider action for adoption.

"We will be going over three motions. The motion to suspend, the motion to reconsider action taken, and the final motion will be the motion to adopt."

On motion by Representative Saiki, seconded by Representative Cabanilla and carried, the rules were suspended to reconsider action previously taken on H.R. No. 87, HD 1; and H.C.R. No. 122, HD 1. (Representatives Cachola, Carroll, Nishimoto, Oshiro, Say and Tsuji were excused.)

Representative Har rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. In support with reservations. Thank you, Mr. Speaker. I want to thank the Chairs of the Health Committee as well as the Judiciary and CPC Committees for what appears to be a compromise measure. I do continue to have concerns, though.

"This is a drastic change from the original House version, as well as the Senate version. We seem to be expanding the universe of doctors that would be allowed to prescribe a registration card. And while the bill itself does ostensibly seem to have a list of purported safeguards regarding bona fide treatment by a physician, I do believe that some of the requirements don't really rise to the level of creating that relationship that a patient would have with either their PCP or a specialist who is dealing with someone who is terminally ill.

"For those reasons, I do understand that the Department of Health may at some point be creating a board that will deal specifically, as the program transitions to the Department of Health, they will be creating a board that will deal specifically with this program. But until that time, and they can make recommendations for safeguards, I'm not clear why we are passing this and expanding the universe of doctors until we get those recommendations from the Department of Health.

"While I do understand that this current draft, the HD 2, was based on recommendations from the Department of Health, until they create those safeguards I think it's premature to move this measure as is. So for those reasons, Mr. Speaker, I continue to support medical marijuana, but for those reasons I'm with reservations. Thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Chair, with reservations, please. A brief comment. It's definitely better than what it was before. It'll likely stem those marijuana carpetbaggers who fly in, and in four days probably run 1,500 or so certificates. It's likely to do that. And I know, having spoken to the Chair of Health in the Senate, he wants to make it as stringent as possible. So whether this sails through conference is probably questionable. Otherwise, it's a better draft than before. Thank you."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

"I just wanted to say how much we're all going to miss her. For someone who worked so hard and someone who's in that important of a position to actually stay for two, two-and-a-half hours at a neighborhood board meeting is pretty remarkable. We are going to miss a remarkable person. *Mahalo.*"

"Mr. Speaker, in strong support. I just wanted to speak on the director's behalf. Serving as the Chair of the Health Committee, being able to serve with her that one year was a tremendous opportunity, and I feel very grateful for that opportunity, and that in this year much of her spirit and her legacy was helping to guide us as we moved forward with legislation. Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with some reservations. This resolution is extraordinarily high technology. Because of that, I think it's subject to misinterpretation and probably abuse or misunderstanding. Number one, because these are self-autonomous robots like Terminator, it has nothing to

do with drones, but I don't think the guy in the street or even anyone in this Body probably knew that until I asked the author and the CPC Chair.

"But if that is the case, Mr. Speaker, we are stepping over the line into national defense and military affairs, and I'm not sure that, as the speech made the other day about a Ukrainian resolution that never got heard, that we should be venturing into saying, 'US Military, don't go and defend the country by getting autonomous robots.'

"I don't even believe there's such a thing as self-autonomous robots. Even Terminator had some commands that you could override, and even with its master it was confused and fought and threw him over the tower, or out the tower window or something like that.

"My point is, Mr. Speaker, this is going to confuse people in terms of drones, in which we are a test site for the US. And secondly, this is stepping outside of our boundary into not only military affairs, but national security in terms of our weaponry. And we do happen to have PACOM down the street, and we should be very cognizant of that.

"Having said that, I would hope it would have been a bit more clear because it's esoteric in terms of this really high technology that I never knew existed until this resolution came out. Having said that, Mr. Speaker, those are reservations that I think are worth of note. Thank you."

Representative McKelvey rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support. First of all, if that is the case, then I would expect that we would be voting with reservations on all of the resolutions expressing support or concern on things that impact the military, like a resolution we just passed the other day asking congress to recognize the benefits to our Filipino veterans.

"That being said, Mr. Speaker, the reality is, this is not drones. This is something that actually came to my attention at the end of last session, Mr. Speaker. And if you look on the internet, if you talk to the groups in Washington D.C., the fact is that lethal autonomous robots, a.k.a. Terminators, systems to which there are no human control during operations, exist. They're being tested and deployed. And so, what has happened is the United Nations along with other countries are proactively taking steps to adopt rules to prohibit the use of these devices because of the fact there is no human control, Mr. Speaker.

"Now, yes, is it a little forward out there? Yes, it is. But, Mr. Speaker, back in the turn of the century there was this other thing out there that was considered, called chemical weapons, Mr. Speaker, and biological weapons. The fact of the matter is that those two were tools of defense to which we all saw what happened. And what the UN and others are looking at is to add lethal autonomous robotics systems to the treaty, basically prohibiting them as weapons of mass destruction, weapons which, in war, could result in civilian casualties, Mr. Speaker.

"And what this tries to do is to say, look, the United States has already taken steps to do this. We support that, and we hope the United Nations and all countries will recognize that this is going in an area to which there could be untold ramifications.

"So, Mr. Speaker, I stand in strong support, but this is something that I hope all will read about and will look and educate themselves, because this is a discussion that should happen before these systems are upon us. A discussion that didn't happen long ago, back in the eve of World War I. Thank you, Mr. Speaker."

Representative Ward rose to respond, stating:

"Mr. Speaker, brief rebuttal. Mr. Speaker, generally speaking we have resolutions because we know something about something. We have 'the Legislature finds', and 'whereas', where we know what's going on.

"This is so esoteric, this is so closed, this is so much new, that to speak authoritatively as a Body I think is presumptuous, I think it's overzealous, and it's getting into a territory which, again, gets into national security.

And if it would please the good Representative from Maui, I will vote no on the bill, having what he just said. Thank you."

"Just reservations, Mr. Speaker, and I would like the concerns of the speaker from Kapolei entered into the record as if they were my own," and the Chair "so ordered." (By reference only.)
