At this time, Senator Nishihara rose to make the following remarks:

“I would like to request that the Senate adjourn on a rising vote and observe a moment of silence in honor and memory of Thomas J. McGarvey.

“Thomas recently passed away on January 8, 2014, due to illness. He was until recently working with ‘Ōlelo here at the Capitol. He did the video reporting of our legislature, did interviews with legislators, and assisted with other members of his team in reporting on our hearings.

“I first got to know Thom when he was the Hawaiian Airlines promoter of the Miss Hawaii Scholarship Pageant in 1980. In that year, I was the Community Development Vice President of the Leeward Oahu Jaycees and the chair of our Miss Leeward Oahu Pageant. The contestants included Paula Akana, along with 10 or so other women. The contestant that was selected to be our Miss Leeward was Ms. Keone Cook, originally from Hilo – a Big Island girl. She went on to win the Miss Hawaii title and was our state’s entrant into the Miss America Pageant.

“Thom’s career spanned four decades, including public relations and communication positions with Honolulu Mayor Eileen Anderson’s administration; the Hawai‘i Visitors Bureau; Department of Business, Economic Development and Tourism; Chaminade University; UH Community Colleges; and finally, ‘Ōlelo.

“I regret his passing and the loss to our community. He was a selfless individual that his friend Ray Abregano noted was a ‘humble steward, mentor, and companion who embodied a beauty of mind, soul, and heart.’ I offer my condolences to his family.

“I request that we adjourn on a rising vote and observe a moment of silence in his memory.” (The Chair so ordered.)

Senator Ihara introduced Cheryl Genet, adjunct professor of philosophy at Cuesta College in San Luis Obispo, California and managing editor of the Collins Foundation Press. Ms. Genet was accompanied by her son John Davidson, a graphic designer from Redlands, California.
