Wednesday, April 16, 2014

The Senate of the Twenty-Seventh Legislature of the State of Hawai'i, Regular Session of 2014, convened at 11:37 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that she had read and approved the Journal of the Fifty-First Day.

At this time, Senator Baker rose to introduce legislative interns Stephanie Lawless from Lahainaluna High School and William Summers from Henry Perrine Baldwin High School, and thanked Senator Ihara and his staff for also being a part of the students' legislative experience that morning.
