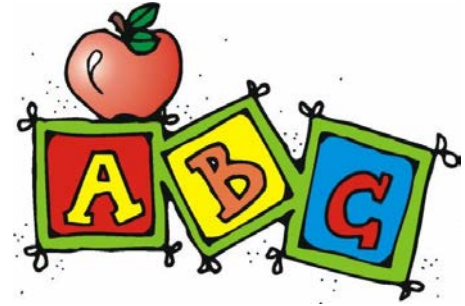

Chair Tokuda and members of the Committee, thank you for the opportunity to appear before you on this matter. I would also like to thank Governor Neil Abercrombie for nominating me. I would further like to express a special mahalo and aloha to those who have been so kind in submitting letters in support of my nomination.

Service on the Board of Education is not something that would have occurred to me absent the encouragement of friends on Maui who were aware of our Maui Board Member Wesley Lo's plans to leave the Board. They felt that I would be able to continue Mr. Lo's active participation and contribution to the Board. In thinking about it, I had to acknowledge that my family has benefitted greatly from our public schools and I felt that, if there is a way I can give back to a system that has provided us with so much, I would be honored to do so.

I am the product of public schools having grown up on Maui and having attended public school all the way through my high school graduation from Maui High School. My mom was a public school teacher, my wife is a public school registrar, and both my kids are graduates of Baldwin High School on Maui. My most recent involvement with the schools has been primarily as a parent helping with Band Boosters, Project Graduation, History Day, Science Fairs and athletics. Our kids have been nurtured and cared for by their teachers and their school community and we could not be more appreciative.

I perceive it as the role and responsibility of members of the BOE to exercise oversight, and provide guidance and leadership in formulating statewide educational policy as it pertains to our public schools and state libraries. In that regard, I think that it is the duty of board members to be prepared, ask good questions, familiarize themselves with the issues, and make informed decisions and recommendations.

I believe that over the course of my career, both professionally as well as a community volunteer, I have gained the skills to be an active and engaged member of the BOE. I have served on many different boards and have, as a result, learned that there is a special 'language' that must be learned whenever entering any new organization. This was true when I served on the board of our local hospital, and I know it is true in education as well. In that regard, I am a

good listener, a quick study, and a level-headed, logical decision maker. I am not one to make decisions based upon emotion but, as a lawyer, I'm all about gathering the best information available and making decisions based upon that information.

I cannot say that I am adequately familiar with the current work of the board to comment on whether the priorities that have been identified for board focus in the coming year are consistent with what I would deem to be priorities. But overall, I think that the board's priorities should focus on the big picture:

Is leadership and vision being provided to inspire change and evolution in education that will provide excellent learning environments for our students?

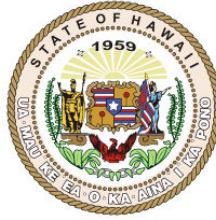
Are the budgets, resources, and facilities being provided to our educators adequate and managed effectively to help them do the best job they can for our students?

Are the benchmarks that have been set for schools and students achievable, realistic, and meaningful?

I think that to provide for community engagement in the formation of education policy it is important to have members on the board who are in fact engaged and involved in their communities. As a lifelong resident of Maui, as a parent, and as an active community volunteer, I feel that I have the kind of background and contact with my community to offer insights that will be helpful in the formation of education policy in the coming years. I understand that the BOE is very committed to proactively seeking community input and I look forward to learning more from the communities served by our public schools.

I don't anticipate any conflicts of interest in my service to the BOE. As I mentioned, my children have already finished high school and, while I do have many friends and contacts, including my wife, who work in the public schools, I don't think that my familiarity with their opinions or concerns will create a conflict of interest for me. More accurately, I think that my awareness of the challenges and demands placed upon our educators will help me to make balanced decisions and provide insights that may not otherwise necessarily be top-of-mind for others on the board.

In closing, I am honored to be considered for this position, and I would be honored by your support for this nomination.







I am pleased to write a letter on behalf of a very good friend and supporter of many good community organizations, Mr. Grant Y.M. Chun.


