In consideration of GOVERNOR'S MESSAGE 518 SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLAND OF HAWAI'I, GUBERNATORIAL NOMINEE, KALENA BLAKEMORE, FOR A TERM TO EXPIRE 6-30-2015

The Department of Land and Natural Resources (Department) supports Governor's Message 518, nominating Ms. Kalena Blakemore to the Island Burial Council, Island of Hawai'i to expire June 30, 2015.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. With regard to previously known burials, the Councils determine whether to leave the burial in place or remove it, recognize lineal and cultural descendants and provide counsel and advice to the Department.

Ms. Blakemore is a resident of the island of Hawai'i. She has a Bachelor of Arts degree in Anthropology and has nine years of experience working at the Hawai'i Volcanoes National Park. While there, Ms. Blakemore was a team member of the Cultural Resource Management Division, responsible for assisting and completing field surveys, drafting maps, site reports, write-ups, conducting 106, Section 110 inventory and monitoring surveys. She also served as an intern with the State Historic Preservation Division in the spring of 2002.

Senate confirmation will ensure that Ms Blakemore's valuable knowledge and perspective informs the deliberations of the Island Burial Council until June 30, 2015.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM518, which would confirm Kalena Blakemore as a Puna regional representative to the Hawai'i Island Burial Council.

Ms. Blakemore's dedication to cultural and natural resource preservation, as well as her archaeological experience, makes her an appropriate selection as a representative on the Hawai'i Island Burial Council. Ms. Blakemore currently resides in Volcano and has genealogical ties to Puna ('Ola'a), Hilo (Keaukaha), and Kohala (Kokoiki). She has extensive experience in the field of historic preservation, serving for many years as an archaeologist in cultural resources management for Hawai'i Volcanoes National Park. During her time at the park, she identified inadvertently discovered burials, implemented protective protocols, inventoried caves, monitored compliance with federal National Historic Preservation Act Sections 106 and 110, and performed high altitude and coastal back country archaeological surveys. Ms. Blakemore received a B.A. in anthropology from the University of Hawai'i, Hilo and interned with the Department of Land and Natural Resources' State Historic Preservation Division. During her time there, she gained a firm foundation in cultural practices and the necessity for balance with the sometimestumultuous issues taken up by the burial councils. Additionally, Ms. Blakemore continues her cultural ties through her participation in native plant restoration on Mauna Loa, Mauna Kea, and Kaho'olawe, attendance at 'Imi Pono No Ka 'Āina Teacher Workshops, study of hula under Kumu Kiwala'o Taylor, and participation as a founding board member of the Volcano School of Arts & Sciences Public Charter School.

For these reasons, OHA urges the committee to <u>PASS</u> GM518 to confirm Ms. Blakemore to the Hawai'i Island Burial Council. Mahalo for the opportunity to testify on this important measure.

There are two people in particular I would like to thank for their inspiration and encouragement

regarding this appointment. I would like to express my gratitude to Dr. Peter Mills, professor of anthropology at the University of Hawai'i, Hilo. His passion and enthusiasm in archeology conveyed to me and other students the importance of cultural resource management. We were exposed to the multi-faceted aspects of cultural resource management and the challenges that come with responsible development and preservation. The second friend and colleague I would like to thank is Sean Naleimaile, State Historic Preservation Division, Hawai'i Island archeologist. He is an excellent leader and role model in our Hawaiian community. He has given me guidance and encouragement to pursue this position expressing to me that we all have skills and talents that are of valuable contribution.

I have ten years of experience working as an archeologist in cultural resources management at Hawai'i Volcanoes National Park. This occupation mandates we follow state and federal protocols if an inadvertent burial is discovered during reconnaissance surveys. I have working knowledge of these governing rules and the sensitivity surrounding iwi kupuna (the bones of my ancestors). Several generations of my grandparents were born and raised on Hawai'i Island. I feel compelled by my Hawaiian heritage to serve and participate in the process of caring for our unique burials here in Hawai'i.

My vision for the Hawai'i Island Burial Council is to gain knowledge and deepen my understanding of Hawaiian culture and support the mission of the Council. In addition, it is my desire we have the ability to maintain a quorum and honor the monthly meetings that need to be held in order to review projects, involve 'ohana and resolve appropriate burial treatment plans. It is my hope to encourage and facilitate productive
