#### In consideration of **GOVERNOR'S MESSAGE 523** SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLANDS OF MAUI AND LĀNA'I, GUBERNATORIAL NOMINEE, IRMALEE POMROY MALY, FOR A TERM TO EXPIRE 6-30-2017

The Department of Land and Natural Resources (Department) supports Governor's Message 523, nominating Ms. Irmalee Pomroy Maly to the Island Burial Council, Islands of Maui and Lāna'i, to expire June 30, 2017.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. With regard to previously known burials, the Councils determine whether to leave the burial in place or remove it, recognize lineal and cultural descendants and provide counsel and advice to the Department.

Ms. Maly is a resident of Lāna'i. Together with her husband, she owns Kumu Pono Associates LLC and serves as a principal researcher and projects manager. Her experience includes working in the field, researching, documenting Hawaiian traditions and history. Her company has developed and published more than 100 Hawaiian ethnographic studies pertaining to traditional cultural properties and landscapes, Hawai'i's communities, cultural practices, and treatment of iwi kapuna. After a brief absence, she recently returned to Lāna'i to continue perpetuating cultural and historic work.

Senate confirmation will ensure that Ms. Maly's valuable knowledge and perspective informs the deliberations of the Island Burial Council until June 30, 2017.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM523, which would confirm Irmalee "Onaona" Pomroy Maly as the Lāna'i regional representative to the Maui and Lāna'i Island Burial Council.

For many years, Ms. Maly has helped enrich her Lāna'i community through cultural and historical research and preservation work. Ms. Maly shares genealogical ties with Lāna'i 'ohana and currently resides there. Since 2006, she has worked with the Lāna'i Culture and Heritage Center to build a robust repository of artifacts from and information about Lāna'i's rich history. Ms. Maly currently serves as an administrative assistant, researcher and web-master for the center. She and her husband Kepā also continue to engage in innovative cultural resource stewardship and education programs for the 'ōpio of Lāna'i.

Ms. Maly has also been engaged in ethnographic and cultural resource management programs statewide for over 35 years. During this time, she has helped facilitate the return of iwi kūpuna to their 'āina of origin, cared for ilina kūpuna, preserved historic sites, conducted hundreds of oral history interviews, recorded historical documents and developed interpretive-educational programs. She is currently completing the initiation of a cultural resource and community stewardship program with the Hoakalei Cultural Foundation and undertaking Traditional Cultural Property Studies through her family business, Kumu Pono Associates, LLC. Ms. Maly's experience in ethnographic research and historic preservation, as well as her desire to pass ancestral wisdom from the kūpuna to the 'ōpio of her moku, make her an exceptional selection for the Lāna'i seat on the Maui and Lāna'i Island Burial Council.

The Maui and Lāna'i Island Burial Council, like several other island burial councils, has recently faced significant challenges meeting composition and quorum requirements as it lost membership sufficient to constitute a quorum in April 2013. Accordingly, during the 2013 legislative session, OHA partnered with the Governor's Office, the State Attorney General, and the Department of Land and Natural Resources' State Historic Preservation Division to pass legislation substantially reducing the composition and quorum requirements for the island burial councils to meet. After the passage of Act 276 (Session

Laws 2013), OHA continued to collaborate with the Governor's Office to expeditiously solicit and recommend nominees to fill vacancies and allow the burial councils to do business once again. With the more attainable composition and quorum requirements established by Act 276 and Ms. Maly's confirmation (as well as those of the three other anticipated Maui and Lāna'i Island Burial Council appointees), the Maui and Lāna'i Island Burial Council may finally resume their work and fulfill their important kuleana.

For these reasons, OHA urges the committee to <u>PASS</u> GM523 to confirm Ms. Maly to the Maui and Lāna'i Island Burial Council. Mahalo for the opportunity to testify on this important measure.


