In consideration of **GOVERNOR'S MESSAGE 524** SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLANDS OF MAUI AND LĀNA'I, GUBERNATORIAL NOMINEE, KAPULANI ANTONIO, FOR A TERM TO EXPIRE 6-30-2016

The Department of Land and Natural Resources (Department) supports Governor's Message 524, nominating Ms. Kapulani Antonio to the Island Burial Council, Islands of Maui and Lāna'i, to expire June 30, 2016.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. With regard to previously known burials, the Councils determine whether to leave the burial in place or remove it, recognize lineal and cultural descendants and provide counsel and advice to the Department.

Ms. Antonio is a resident of Makawao, Maui. She holds a Bachelor's degree in Hawaiian Studies and a Master's degree in Pacific Islands Studies. She is currently employed as a Hawaiian History teacher at the Kamehameha Schools-Maui campus. In addition, she also taught Hawaiian language and Hawaiian studies at both the Maui College and Hilo College. Ms. Antonio also worked as a curriculum developer and editor for the Kula Kaiapuni Hawaiian Immersion schools. Her community involvement includes membership in the 'Ahahui Ka'ahumanu Society and the Ka 'Ohana o Kalaupapa. She is fluent in Hawaiian and wellexperienced in oli.

Senate confirmation will ensure that Ms. Antonio's valuable knowledge and perspective informs the deliberations of the Island Burial Council until June 30, 2016.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM524, which would confirm Kapulani Antonio as the Makawao regional representative to the Maui and Lāna'i Island Burial Council.

Ms. Antonio's experience with traditional burial practices and cultural education will serve the Maui and Lāna'i Island Burial Council well. Ms. Antonio has been a Hawaiian History, Language and Culture instructor at UH Hilo, UH Center Maui, Maui Community College and Kamehameha Schools Maui for over 20 years. She has also served as the Hawaiian Language Translator and Specialist for the Ka Ho'olina Journal and as the Editor and Curriculum Specialist at Hale Kuamo'o at UH Hilo. Ms. Antonio has consistently sought to convey a deep respect for iwi kūpuna, teaching her students to revere iwi as the vessels of our ancestors' mana. She has paid close attention to cases of iwi protection and has assisted in executing cultural protocols including making kapa for iwi re-interment. Although she has only lived in Makawao for 13 years, she has indicated her intent to root her family in the Makawao community indefinitely.

The Maui and Lāna'i Island Burial Council, like several other island burial councils, has faced significant challenges meeting composition and quorum requirements, particularly since it lost the membership sufficient to constitute a quorum in April 2013. Accordingly, during the 2013 legislative session, OHA partnered with the Governor's Office, the State Attorney General and the Department of Land and Natural Resources' State Historic Preservation Division to pass legislation substantially reducing the composition and quorum requirements for the island burial councils to meet. After the passage of Act 276 (Session Laws 2013), OHA continued to collaborate with the Governor's Office to expeditiously solicit and recommend nominees to fill vacancies and allow the burial councils to do business once again. With the more attainable composition and quorum requirements established by Act 276, and with Ms. Antonio's confirmation (as well as the confirmation of the three other anticipated Maui and Lāna'i Island Burial Council appointees), the Maui and Lāna'i Island Burial Council may finally resume their work and fulfill their important kuleana.

For these reasons, OHA urges the committee to <u>PASS</u> GM524 to advise and consent to the nomination of Ms. Antonio to the Maui and Lāna'i Island Burial Council. Mahalo for the opportunity to testify on this important measure.

Aloha kākou. My name is Cody Pueo Pata and I am the kumu hula of Hālau Hula Ka Malama Mahilani (Kahului, Maui), a Hawaiian recording artist (Ululoa Productions), as well as a private Hawaiian language and cultural specialist/consultant from the island of Maui

I submit this written testimony regarding GM524, in full support of Gubernatorial Nominee, Kapulani Antonio, and her consideration and confirmation for a position upon the Island Burial Council, Islands of Maui and Lāna'i.

I have personally known Kapulani Antonio for over 10 years—meeting her first as a student in her Hawaiian language classes at the former Maui Community College, working with her professionally as a colleague during my years of teaching at Kamehameha Schools Maui High School, and now as a personal friend to whom I turn for wisdom and insight. I sincerely view Kapulani Antonio as a moral, level-headed, and upstanding citizen with a strong drive for education and justice. From these capacities do I lend my support.

With a 25-year career in education reaching back to 1989, Kapulani has become an accomplished academic, published author/editor, translator, consultant, and teacher of Hawaiian history, language, and culture. Through these venues, she has committed to being a lifelong proponent of enlightenment for the masses, as well as for the empowerment of the Hawaiian people.

These endeavors have enabled Kapulani to become adept at various types of research which include delving into archival and community-based (oral/personal/etc.) resources. As an eloquently fluent speaker of the Hawaiian language, Kapulani is afforded unlimited access to the knowledge found within primary-source texts, as well as oral testimonies and/or recordings, in the Hawaiian language that may, or may not, have been translated into English. With her skills in language and her firm foundations in Hawaiian culture and history, she is afforded clear insight into the mindsets of the authors of, or informants for, such resources, and, thusly, into the mindsets of our ancestors.

In her capacities as a professional team leader and program manager, I have come to know Kapulani Antonio to be meticulously organized, as well as methodic and measured

in decision making. In various discussions, I have been privy to some of the various types of considerations which she utilizes in her decision-making processes. These considerations range from family-based knowledge/traditions, community-based practices/sentiment, academia, official/professional procedures, cultural protocols, *pule* (prayer), as well as her *na'au* ("gut-feelings" toward that which is *pono* [proper/in the right]).

As someone who is genealogically connected to Maui's lineages, Kapulani Antonio feels it is her *kuleana* (responsibility) to continually strive toward the protection, preservation, appropriate management, and/or treatment of Native Hawaiian burial sites, skeletal remains, and burial goods. Due to her ancestral connections, as well as her economic investments in the land as a Maui-based landowner, Kapulani's senses of lasting *kuleana* have driven her to seek a position upon the Island Burial Council for the Islands of Maui and Lāna'i.

Therefore, I feel passionately that Kapulani Antonio—due to her well-versed cultural, linguistic, and academic background, conscientious abilities in decision making, and as one with a deep sense of *kuleana* to the past, present, and future generations of Hawai'i—is a Gubernatorial Nominee that is most definitely qualified to uphold the rules of practice and procedures relating to human burial sites and remains as outlined in the "Hawai'i Administrative Rules—Title 13, Department of Land and Natural Resources; Subtitle 13, Historic Preservation Division; Chapter 300, Rules of Practice and Procedure Relating to Burial Sites and Human Remains" (www6.hawaii.gov/dlnr/hpd/pdfs/burrules.PDF).

Please consider and confirm Kapulani Antonio for a position upon the Island Burial Council, Islands of Maui and Lāna'i.

Aloha. He wahi mahalo kēia iā 'oukou, iā OHA, i ke Kia'āina Abercrombie nō ho'i no ka hāpai 'ana i ko'u inoa i mua o oukou. Mahalo nō ho'i i ka po'e i kāko'o mai ia'u ma ke kākau leka 'ana a me nā hoa kāko'o i hele mai nei i kēia lā.

'O au 'o Kapulani Antonio. I was born and raised O'ahu. I moved to Hawai'i island where I earned my Bachelor of Arts in Hawaiian Studies and where I also taught Hawaiian language and culture at the University of Hawai'i at Hilo for a little under ten years. I was an active part of the Hawaiian community there. It's where I came into political consciousness. My husband, kids & I moved to Maui and have been there for 15 years now. Over that period of time I taught Hawaiian language and Hawaiian Studies at Maui Community College, and at UH Center, developed curriculum for Kula Kaiapuni Immersion schools. I currently teach Hawaiian History at Kamehameha Schools Maui.

As part of my curriculum, we cover the history of Honokahua - the unearthing of over 800 sets of iwi kupuna and the grassroots efforts of people like Dana & Isaac Hall, Uncle Charlie Maxwell and Uncle Les Kuloloio. We discuss the establishment of the burial councils and talk about the challenges the councils face today especially on O'ahu. As we continue to meet the needs of our growing population through responsible development, iwi kupuna will no doubt continue to be unearthed.

As a member of the Maui Island Burial Council my kuleana will be first and foremost to advocate for the iwi kupuna. I believe in preserving the iwi in their respective burial places first. In the event that relocation is required, proper steps will be taken to respectfully reinter them in an appropriate location which makes sense and is pono for them. It goes without saying that such a circumstance would careful consideration and proper protocol to ensure that the process is undertaken with the utmost respect and humility.

I am qualified to serve on the Council because of my years as an educator in the field of Hawaiian Studies. During that time I have served on the leadership team as an advocate for my colleagues in my academy. I worked with counselors, administrators and other members of the faculty and staff to make important decisions that would affect our school community. It was through both teaching and leading that I honed my skills as leader, listener and consensus builder. I am an action

oriented person who wants to get the job done and am ready to make the important decisions that come my way.

Serving on the Burial Council is a tremendous kuleana that I do not take lightly. Thank you for considering my nomination.
