TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Catherine Awakuni, and I am the Cable Television Administrator at the Department of Commerce and Consumer Affairs (the "**Department**"). The Department appreciates this opportunity to provide testimony regarding the nomination of Gerry Silva to the Cable Advisory Committee ("**CAC**") for an additional term. The Department supports Mr. Silva's nomination and respectfully requests that your Committee recommend that the full Senate advise and consent to his nomination to the CAC.

Mr. Silva has a long and distinguished career of service in the community, including previous service as a CAC member, and has held various communications related positions with the State and the City and County of Honolulu. Among these positions, Mr. Silva worked as the City Information Officer for the City and County of Honolulu and was named Special Assistant to the Managing Director in 1997. He also worked as the Deputy Director of the Customer Services Department of the City and County of Honolulu where he managed various programs and services of the city including the Public Communications divisions. Later, Mr. Silva served as the Director of Communications and Special Projects for the Hawaii Tourism Authority where he spearheaded efforts to organize and direct the 2001 Annual Meeting of the Asian Development Bank.

Mr. Silva first served as a member of the CAC in 2004. However, he resigned his position with the CAC in 2005 to take the Chief Operating Officer position with `Ōlelo Community Media, one of the largest community access stations in the county, and Oahu's public, education, and government ("**PEG**") access organization. At `Ōlelo Community Media, he managed the organization's multi-million-dollar operating and capital budgets, developed and implemented strategic goals and organizational policies, and managed the organization's operations until he resigned in 2008.

Mr. Silva was re-appointed to the CAC, and currently, he serves as the Oahu atlarge member of the CAC. Mr. Silva is a conscientious board member and does not miss a meeting. Because of his knowledge and experience as a communications professional, Mr. Silva has provided valuable contributions to the CAC. The Department values Mr. Silva's contributions and insights and believes that he should be reappointed to an additional term through this nomination.

The Department supports Mr. Silva's nomination and respectfully requests that the Senate Committee on Commerce and Consumer Protection recommend that the full Senate advise and content to his nomination to the CAC.

Questions With Respect to Confirmation of Gerald Silva as a Member of the Cable Advisory Committee

(1) Question: Why do you wish to be a member of the Cable Advisory Committee?

<u>Answer</u>: This is an opportunity to serve my community in a field that I understand.

(2) <u>Question</u>: What do you perceive are the roles and responsibilities of a member of the Committee?

<u>Answer</u>: This is an advisory position. It requires that committee members provide advice on cable and broadband services—as requested—to the director of the Department of Commerce, cable operators, and access organizations. This is specified by Chapter 440G-13.

(3) Question: Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Committee.

Answer:

- Knowledge of Chapter 440G that I acquired during previous terms on the Cable Advisory Committee.
- Skill as an active producer of cable television shows. I understand the production and cable casting process.
- Experience in reviewing and commenting on franchise applications and PEG contracts. This was part of my job as the Chief Operating Officer (COO) of Olelo Community Media.

- 2012 to 2014. Nominated by Governor Abercrombie and confirmed as a member of the Cable Advisory Committee. Worked with DCCA Director Kealii Lopez and the cable division staff.
- (7) Question: Can you foresee any possible conflicts of interest that could arise during your service on the committee? How would you overcome conflicts of interest?

<u>Answer</u>: I foresee no conflicts of interest. I would overcome any by recusal or—if very serious—by resignation.
