(1) Why do you wish to be a member of the Board of Directors of the Hawaii Health Connector?

My tenure in Public Health in Hawai'i over the past 25 years has been focused on improving the health and wellness of Native Hawaiians and Pacific Islanders. These populations continue to be overrepresented in the medically uninsured and underserved. Under the Affordable Care Act, this can be addressed through the prepaid health plans.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

The kuleana of Board members are to work collectively and thoughfully to oversee the implementation of the Hawai'i Health Connector through the development and implementation of appropriate policies that support effective, culturally relevant outreach and recruitment and, program viability and sustainability.

(3) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

My 25 years in Public Health have been focused on Native Hawaiian and Pacific Islander community health and wellness. Prior to joining Papa Ola Lōkahi, I served as Director of Research Education and Training at the Rehabilitation Hospital of the Pacific and Director of the Governor's Pacific Health Promotion and Development Center which focused on health disparities in Hawai'i and the U.S. Affiliated Pacific. At Papa Ola Lōkahi since 1999, I have spearheaded federally-funded programs from NIH, NCI, HRSA and CDC to support programs for cardiovascular health, cancer prevention and control research and education, and diabetes prevention and control in Hawaiian and Pacific Islander communities.

As a founding member and current Director of 'Imi Hale Native Hawaiian Cancer Network our 'Imi Hale team has developed a robust, community-based infrastructure to support cancer education and awareness in Native Hawaiian communities, community-based participatory research and cancer patient navigation. To address the lack of culturally relevant health education materials for Hawaiian and Pacific Islander communities, I have led and overseen the development of over 100 culturally tailored health education materials—each one engaging the intended community in the development and distribution of the products. As a Native Hawaiian, I strive to be sensitive to the historical disparities in health, education, and well-being among Hawaiians, who in our own homeland fare poorly when compared to our non-Hawaiian counterparts. My education and experience throughout my professional career has focused on public health education, community mobilization and capacity building in the groups I am privileged to serve. I believe these to be strengths that will add to this effort.

(4) What do you hope to accomplish during your term of service?

During my term of service I hope to add a community "voice" and community perspective to all facets of this enterprise to promote equitable outreach that considers and incorporates an understanding of the diverse groups that can and should benefit from the ACA. Outreaching to the "hard to reach" and the "hardly reached" populations require community engagement and effective communication. As a Public Health Educator and trainer in health communication I would like to offer my expertise in this area to facilitate effective outreach and recruitment.

 - 1) Demonstrated ability to communicate health messages to Native Hawaiian and Pacific Islander communities
 - 2) Able to convene appropriate partners for actionable outcomes
 - 3) Demonstrated experience in community organization and advocacy
- (6) Name a previous experience you've had that will be beneficial as a Board member.

I was fortunate to participate in the efforts to pass and implement the Native Hawaiian Health Care Act of 1988 and the reauthorization in 1992, and subsequently participated in forming Papa Ola Lōkahi and Na Pu'uwai, the Native Hawaiian Health Care System on the island of Moloka'i. These seminal milestones required coordination, collaboration and commitment from Hawaiian communities, Hawaiian health care professionals and paraprofessionals, and our congressional leadership. Through legislation that was vetted statewide in Hawaiian communities, the commitment was made to invest in building the capacity within Hawaiian communities to identify, address and improve the

health status and wellness of Native Hawaiians. As part of this movement I served as a member of E Ola Mau, a grants writer, a facilitator of community forums on all islands, a program developer, a community representative at national forums and a research coordinator. This 23-year experience provided, and continues to provide the relationships and values that guide my current work in health disparities research and programming and hopefully, my contributions to this board, should I be approved.
