My name is Fituina F. Tua and I support Joyce Matsumori-Hoshijo ("Joyce") for reconfirmation to the Hawaii Parolying Authority / Parole Board. I have known Joyce for 1-year working along side her as a member of the Hi. Parole Board. Having retired from federal employment with the U.S. Probation Office, U.S. District Court in Hawaii and having over 30 years in the criminal justice field, I can only best describe Joyce as a person who is well "qualified and more" to be on the Board. She brings years of experience as a former defense lawyer for the public defender's office and private practice, where she has worked with the offender population on their legal and rehabilitation issues. She has a good working knowledge in understanding the offenders, the victims, and the community. She brings a fair assessment and perspective on the issue of crime and punishment as well as the importance of rehabilitation. She understands the state of Hawaii's indeterminate sentencing laws, the Department of Public Safety's Correctional policies, and the vital role that the parole board plays in this process. Dear Senator Espero, Senator Baker and Members of the PSM Committee:

I am very honored to be nominated to a second term as a part-time member of the Hawai'i Paroling Authority ("HPA"). I wish to thank Governor Abercrombie for his consideration and confidence.

Thank you very much for the opportunity to present written testimony to the members of the Public Safety, Intergovernmental and Military Affairs Committee. My sincere apologies for being unable to attend my confirmation hearing on March 6, 2014. I am required to be at HPA hearings in Hilo on that day to participate in decision-making for cases which were carried over from our February hearings.

I began my first term with the HPA in May of 2011. From the beginning, I was very motivated to work with other HPA members to bring a high level of professionalism and competence to the parole decision-making process. As a criminal defense attorney for over twenty years, I represented many clients before the HPA and had extensive discussions with former HPA members and staff about HPA practice and procedure. I served for two years as Grand Jury Counsel, providing legal guidance to Oahu Grand Jury panels and interacting regularly with deputies from the Office of the Prosecuting Attorney and the Department of the Attorney General concerning criminal law issues relevant to their Grand Jury cases. I served as a member of the Penal Code Reform Committee, composed of representatives from all areas of the criminal justice system. This Committee was tasked with preparing a report to the State Legislature identifying needed revisions to the Hawai'i Penal Code. These work experiences gave me a strong foundation to take on the responsibilities of an HPA member.

The best training, however, was to become immersed in the decision-making process itself. Although I understood generally the functions of the HPA, the day-to-day work was very challenging. It requires a great deal of physical and mental stamina

to adjudicate an average of twenty cases per day and remain focused through each of the presentations. It requires emotional strength and objectivity to listen to the testimonies of victims and families in cases involving serious bodily harm and loss of life.

The HPA decides nearly four hundred minimum term, parole, and parole violation cases each month. The recent addition of two new part-time HPA members in 2013 has helped tremendously in distributing the workload.

Through the high volume of cases, our discussions during decision-making, and research done on the applicable statutes and case law, I have developed an in-depth understanding of the entire parole process during the past two and a half years. I recognize the enormous responsibility the HPA members have in deciding the length of time an inmate must serve in prison and whether an inmate is ready to be released on parole supervision.

While the HPA does have considerable discretion in decision-making, the boundaries of our discretion are set by the applicable law. Our task is to follow the law while balancing relevant factors on a case-by-case basis. I do believe that during the tenure of the current Board, we have made best efforts to ensure that every decision comports with our HPA Guidelines, administrative rules, statutes and case law.

When first appointed to this position in 2011, I felt that the role of an HPA member was to make fair and legally sound decisions in order to protect the community and reintegrate the inmate into the community. I firmly believe that community safety is of paramount importance. Key to reintegration is for the inmate to complete institutional programming which provides for the highest chance of success in the community.

A valuable aspect of our work is collaborative effort. Each HPA member comes from a different sector of the criminal justice system. Together, we balance our common and divergent perspectives and strive to reach consensus in every case. We sometimes have animated discussion and debate but remain respectful of each other's viewpoints. I feel very fortunate to work with an outstanding group of individuals who have the highest ethical standards. I have learned a great deal from their knowledge and life experience. I look forward to continuing our work in the years ahead.
