Thank you for this opportunity to provide testimony on Governor's Message No. 555, submitting for the consideration and confirmation of Jason Misaki to the Advisory Committee on Pesticides. The Hawaii Department of Agriculture (HDOA) would like to express its strong support for Jason's nomination and confirmation to the Advisory Committee on Pesticides.

Jason is currently the Wildlife Manager, Oahu Branch at the Hawaii Department of Land and Natural Resources, Division of Forestry and Wildlife (DOFAW). He has extensive experience at analyzing land management techniques to gauge their efficiency and effects on the environment. The use of pesticides by DOFAW and other landowners, serve a large part of the land management process.

DOFAW also oversees and protects native species and permits the destruction on nonnative nuisance species, some via pesticide use. Along with the HDOA, Jason works with landowners, pest control companies and private residents to develop best practices to control nuisance pests and ensure that these practices do not negatively impact native plants and animals.

Jason has expertise in investigating pesticide/pollution related wildlife kills and provides mitigation strategies or alternative actions to prevent continued contamination. His knowledge of the potential impacts of pesticide use to native species and ecosystems will be a good asset to the Advisory Committee on Pesticides.
