It is my great pleasure to submit this letter in support of the Committee's recommendation for confirmation of Judge Michael D. Wilson as Associate Justice of the Supreme Court of Hawai'i.

I have known Michael Wilson as a colleague and wonderful friend for 32 years. He is a remarkable person whose intelligence, integrity, commitment to social and environmental justice, energy, and fair, calm yet engaged demeanor are the hallmarks of his character. He will bring to the Court a brilliant and rigorous mind to its deliberations along with remarkable collegiality. Your recommendation for confirmation of this distinguished jurist will support and enhance the cause of justice and thereby benefit all the people of Hawai'i.

I first met Michael Wilson in 1982 as a young associate defense co-counsel on a federal criminal matter we were trying in U.S. District Court in Honolulu before the great Judge Samuel King. During the many months of intense preparation and jury trial, I got to know him well. Even then he evinced all the qualities of character, demeanor, legal acuity, and unstinting work ethic, which characterize a fine attorney and eminent jurist. I was delighted and not surprised, when he was appointed to the Honolulu Circuit Court bench.

Over the years through our many conversations in Hawaii and California, I became aware of his consistent active involvement and achievements in helping to solve community and

environmental issues --both professionally and as a citizen. But I would like to highlight in particular his commitment to fairness to and support of victims of domestic violence.

From June, 1996 to January, 1997 I had the honor of serving the Legal Aid Society of Hawaii as consulting managing attorney of the Maui Office and consultant on the Oahu and Neighbor Island programs. Domestic violence was an ongoing and growing problem on Maui, but a very high incidence of victim recantations as well as lack of targeted civil legal assistance hindered safety and prosecutions.

At my home legal aid program in Marin County, we had developed a successful, grant-supported domestic violence collaborative effort to address, in particular, victim recantation with civil legal services for financial support, evictions, custody, dependency and other severe barriers to safety and criminal prosecution of domestic violence and harassment. I hoped to set up a similar program, tailored to the specific community ethos and needs of Maui.

Michael Wilson actively and generously supported our efforts in Maui by sharing his knowledge and insights and most effectively helping me connect with the director and staff of the Maui Prosecuting Attorney's Office of Victim Assistance and the domestic violence prosecution team as well as suggesting or putting me in touch with key activists in the domestic violence support and advocacy community, such as the police and community groups such as, Women Helping Women, and Child and Family Services. His support was meaningful to and enhanced LASH's domestic violence efforts and successful collaboration with the community.

Later, when Judge Wilson served on the domestic violence docket of the Family Court, we had many conversations in which he expressed his commitment to fairness and victim safety in challenging cases that appeared before him.

I urge your unanimous recommendation confirmation of the eminent and highly qualified Michael D. Wilson to the full Senate.

Dear Senator Hee and your fellow Senators:

I'm submitting this testimony in support of Judge Michael Wilson's nomination and hopefully confirmation as an Associate Justice of the Hawaii Supreme Court. I have known Mike for over 35 years. He was my boyfriend for about 8 years, then we were law partners for many years until he was appointed to head the DLNR, after which he became a full-time public servant, including as a Circuit Court Judge. We have remained close friends over the years. I know him and his family well and am also aware of his fine reputation in our community.

I have seen first- hand his very real and working respect for people of all backgrounds and

from all walks of life, from our staff at our law firm to a neighbor to our families and friends to opponents in lawsuits to the prisoners in the Drug Court. I have never seen Mike even raise his voice in anger or impatience in situations where the average person (including me) would have done so. He is remarkably calm and judicious. He brings out the best in other people. He is a kind, generous, intellectually energetic and optimistic person. His appreciation of divergent viewpoints is genuine. I've never known anyone with a better ability to bring people together to achieve common consensus. His integrity is unimpeachable and he has never been driven by a desire for power or personal aggrandizement.

In his public positions there have been those rare situations where someone who for their own personal reasons sought, unfairly, to damage his reputation in order to undermine him but he has never stooped to their level. He has a good, solid moral core. He has never shied away from controversy in his work, some of which was necessarily contentious, so there are those who have disagreed with his positions, but there has never been a legitimate question about his honesty or integrity. There would never be a concern that his decision making was subject to political or other improper influence. He has a deep and abiding respect for the law and the judiciary's limited but important role in our democracy. He loves being a Judge. He is humbled by the responsibility and takes his job very seriously. Even when Mike isn't on the bench or at the office he's working because the law is not a chore to him. Being a lawyer and a Judge is who and what Mike is. I'm sure you know other such dedicated public servants but they are rare and, to me, inspiring...Mike is in that category. I don't believe there could be a better nominee for this position.

I have practiced law in Hawaii since 1977. I have always been a litigator, primarily plaintiffs' personal injury law but also as a prosecutor intern in law school, criminal defense during my first 10 years of practice and limited commercial and other litigation during the past 5 years or so. As a litigator representing primarily individuals in our judicial system my interest in the integrity and quality of our trial and appellate judges could not be more serious. It is essential to my clients that they have access to a level playing field in Court with the certainty that Hawaii law will be fairly and equitably applied by Judges who are knowledgeable, well-prepared, and who are free of political or other improper personal bias. Mike fits that description. He would never succumb to improper influence and is dedicated to preserving constitutional and other legal rights as established by the Legislature. He is an avid legal scholar, is an excellent legal writer, and recognizes the importance of precedent to the stability of our society and, on a micro level, to our advice as lawyers to our clients.

I also believe that a real world understanding of the broader impact on society of appellate decisions is critical to the development of our case law. Of all the candidates who made the list for this important position, Mike stood head and shoulders above in terms of the breadth of his experience in both the public and private sectors and that range of experience is invaluable at the appellate court level. He was a law clerk for Federal Judge Samuel King and Intermediate Court of Appeals Judge Frank Padgett and a well-respected litigator on important consumer and individual rights cases. He worked on legislation to preserve the rights of victims of sexual harassment. He has been a Circuit Court Judge with various assignments including presiding over the Drug Court and substituting on the Hawaii Supreme Court. He served as the consumer advocate, worked with community groups to preserve the Kaiwi Coastline and Kawainui Marsh, and his commitment to and respect for the Hawaiian culture and Hawaiian rights has always been a force in both his public and private work. Mike has also contributed time to various non-profits over the years, most recently working with disadvantaged youths. That wide range of experience and public service would be a

invaluable contribution to the Hawaii Supreme Court.

I am frankly a bit appalled at the governing body of my HSBA which would seek to disqualify him from this position without citing any reasons, polling its members, or apparently conducting other investigation. The HSBA has demonstrated an unfortunate pattern in the past and, in my opinion, its rating should be disregarded by the Committee. The HSBA rating flies in the face of the fine ratings that Judge Wilson has achieved in his past judicial service.
