(1) Why do you wish to be a member of the Board of Massage Therapy?

I have been a board member from August 2008 and would like to continue to make a difference in my profession. Our laws are antiquated and need to be updated with respect to the trends in the profession as well as the legal boundaries. I feel that having worked as a licensed massage therapist for 17-1/2 years and teaching for over 10 years, along with my experiences as an officer of my professional association, I am qualified to bring my experience and knowledge to the table.

I believe that conflicts of interest will be at a bare minimum because I understand my role as a board member to be neutral and recuse myself if a conflict exists. I would overcome conflicts of interest by evaluating the situation and ask for guidance/counsel if I am not able to provide an unbiased decision/opinion. Conflics of interest with other Board members would be at a minimum because I would look at the required outcome, based on the laws, for the good of the people involved and not just the benefit of one person.
