TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND TO THE HONORABLE BRIAN T. TANIGUCHI, VICE CHAIR, AND MEMBERS OF THE COMMITTEE:

The Department of Commerce and Consumer Affairs ("Department") appreciates the opportunity to testify on Governor's Message No. 632, regarding the appointment of Russell Chung to the Board of Physical Therapy ("Board"). My name is Keali'i Lopez, Director of the Department.
