In consideration of GOVERNOR'S MESSAGE 646 SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLANDS OF MAUI AND LĀNA'I, GUBERNATORIAL NOMINEE, KAHELEONALANI DUKELOW, FOR A TERM TO EXPIRE 6-30-2015

The Department of Land and Natural Resources (Department) supports Governor's Message 646, nominating Ms. Kaheleonalani Dukelow to the Island Burial Council, Islands of Maui and Lāna'i to expire June 30, 2015.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. With regard to previously known burials, the Councils determine whether to leave the burial in place or remove it, recognize lineal and cultural descendants and provide counsel and advice to the Department.

Ms. Dukelow was born and raised on Maui. After graduating from high school, she attended the University of Hawai'i where she earned degrees in Hawaiian Studies, Hawaiian Language and Education. She is currently a faculty member at the University of Hawai'i Maui College and had formerly taught in the Department of Education Kula Kaiapuni program for nine years. She is also involved in a stewardship program involving a 21 acre culture preserve located in the same moku (Honua'ula) she is being nominated to serve. Ms. Dukelow's reputation in the Maui Community as an advocate for perpetuating and preserving native Hawaiian culture and is well known and respected.

Senate confirmation will ensure that Ms. Dukelow's valuable knowledge and perspective informs the deliberations of the Island Burial Council until June 30, 2015.
