SUBJECT: GM 669 - State Council on Developmental Disabilities Gubernatorial Nominee Caroline Cadirao

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 669** to confirm the nomination of Caroline Cadirao for a term to expire June 30, 2018.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The law specifically requires that 60 percent of the membership of the Council be comprised of individuals with DD, their parents, or family members. Additionally, the following agencies are required to be on the Council: Department of Health; the agencies that administer funds provided under the Rehabilitation Act of 1973; the Individuals with Disabilities Education Act; the Older Americans Act of 1965; Titles V and XIX of the Social Security Act; the Protection and Advocacy Agency; the Centers for Excellence in DD Education, Research, and Service; agencies and private non-profit organizations concerned with services to individuals with DD. The Governor's nominee meets all the Federal requirements for Council membership.

Ms. Cadirao is Grants Manager for the Executive Office on Aging. She was appointed by Governor Lingle on October 30, 2009, on an interim basis and confirmed by the State Senate in 2010. Her reappointment fulfills the requirement to have a representative from the Older Americans Act of 1965. As a representative from the Executive Office on Aging, Ms. Cadirao would assist the Council in bringing together the The Honorable Josh Green Page 2 April 9, 2014

aging and disability networks to increase collaboration among agencies, especially at a time of limited and reduced resources.

She is a member of the Council's Community Supports Committee that addresses the goal, "People with developmental disabilities will receive the necessary supports to live self-determined lives and have equal access under the law." She would be able to contribute her expertise in addressing the development of policies for home and community-based approaches that cut across the aging and disability populations. Her experience is an asset to the Council in promoting systems change and advocating on behalf of individuals with DD and their families.

We look forward to Ms. Cadirao's continued appointment to the Council. Thank you for the opportunity to express our strong support for **GM 669** to confirm Caroline Cadirao to the State Council on Developmental Disabilities.
