UHARI has been an excellent sounding board for new initiatives at RCUH and Dr. Duffy has been attending RCUH Board meetings for several years. He has a real understanding of RCUH business processes and good sense of the Board's interests and concerns. If confirmed, will be an excellent addition to the Board.

Dear Senator Taniguchi, Senator Kahele, and members of the Committee:

This is testimony in support of the nomination by Gov. Abercrombie of Prof. David Duffy to serve on the RCUH Board of Directors. Prof. Duffy is an outstanding nominee for Director on the RCUH Board, and I urge you to confirm his nomination to that position.

I am writing to you as a long-time University of Hawaii faculty marine researcher concerned with the future successes of research at UH. As you know, the Research Corporation of the University of Hawaii (RCUH) by charter provides crucial research support services to UH researchers that are difficult, if not impossible, for UH to provide in a timely manner. During more than 30 years I have observed firsthand the importance of RCUH in my own research programs. It is safe to say that the large grants that I have received could not have been successful without the timely, focused efforts of RCUH.

In recent years, a representative of the University of Hawaii Association of Research Investigators (UHARI) has been invited to participate ex officio in the public portion of RCUH Board meetings. Both Prof. Duffy and I, as leaders of UHARI, attended the quarterly RCUH Board meetings. The particular RCUH Director position for which Prof. Duffy has been nominated was created by legislation passed in 2013, specifying the appointment of an active UH faculty researcher to the RCUH Board. This legislation formalized the direct representation of UH researchers in RCUH Board matters. I know that Dr. Duffy is well-qualified for this Director position, and that he will provide important experience to inform the Board in its deliberations and decision-making as a voting Board member.

Prof. Duffy is a top UH researcher, he has had considerable experience with RCUH, and he understands what is needed to represent UH faculty research interests on the RCUH Board. Prof. Duffy is also well aware of the importance of UH research to the economy of the State of Hawaii, and the role of the RCUH.
