Dear Honorable Chairman Taniguchi and the Senate Higher Education Committee,

I am pleased to support the appointment and confirmation of Ms. Charlotte Townsend to the Hawaii Commission for National and Community Service for a second term.

This Commission enacted by Federal Statute, is responsible for administering and receiving federal funds to support AmeriCorps Programs in the State of Hawaii. Chair Taniguchi, Vice Chair Kahele and Members of the Senate Committee on Higher Education, thank you for the opportunity to provide testimony before you today. I would also like to thank Governor Abercrombie for this nomination.

My name is Charlotte Townsend and I am a nominee for the Hawaii Commission for National and Community Service. I was born and raised in Hawaii and have been an active participant in many community service organizations and projects during my working career. I believe my background, experience and years of volunteerism makes me a viable candidate for this appointment.

I am a graduate of St. Andrew's Priory in Honolulu and Whittier College in California. I attended graduate school at UCLA and the University of Hawaii at Manoa. I have been employed at the Department of Health, Disability and Communication Access Board, since 1990 serving as the prior Assistant Director and the current Program and Policy Development Coordinator. In my job I am responsible for the dissemination of information on community resources for persons with disabilities as well as being a trainer and lecturer on civil rights legislation, including the Americans with Disabilities Act, the Rehabilitation Act, the Air Carriers Access Act and the Federal Fair Housing statutes.

I have also worked for many private non-profit agencies in California and Hawaii as a teacher, vocational rehabilitation counselor, program director and administrator. I have been called upon to serve on many Executive Boards utilizing my background in special education and vocational education. I was a Governor appointee to the Commission on the Handicapped in 1981 where I served three terms representing myself as a consumer with polio. I have served on the Executive Board of Directors for many non-profit human services organizations as well as community and condominium associations.

In 2011, I was appointed to the HCNCS Board and will complete my first term in June 2014. I am honored to have been asked to serve an additional term. I believe that community service enriches our lives and offers opportunities to give back to others. I am a passionate advocate for the full participation of persons with disabilities in all facets of the community and I will continue to bring this voice to the projects of the HCNCS.
