The Department of Land and Natural Resources (Department) supports the Governor's nomination (Governor's Message 703) of Mr. Michael Buck to serve on the Commission on Water Resource Management ("Water Commission") for a term to expire 6-30-18..

Hawaii Revised Statutes (HRS) §174C-7(d) provides that an independent nominating committee composed of two (2) members selected by the Governor, one (1) by the Senate President, and one (1) by the Speaker of the House of Representatives solicits applications by public notices published in newspapers statewide, in the Water Commission's monthly bulletin, and on the Water Commission's website. The Nominating Committee reviews applications and sends the names of at least three qualified individuals for each opening to the Governor for consideration.

HRS §174C-7(b) provides that Water Commission members must have "substantial experience in the area of water resource management." In addition, one member must "have substantial experience or expertise in traditional Hawaiian water resource management techniques and in traditional Hawaiian riparian usage such as those preserved by" HRS §174C-101.

Following this nominating process, the Governor selected Mr. Michael Buck.

Mr. Buck began his career as a Resource Survey Forester in the Department's Division of Forestry and Wildlife ("DOFAW"). After ten years, he was promoted to Natural Area Reserves Coordinator, then two years later to the Division's top administrator post. Mr. Buck served a total of 27 years in public service at DOFAW managing Hawaii's priority forested watersheds and advocating for forest stewardship and recovery. His many accomplishments at DOFAW include drafting and leading multi-constituent support for the passage of major legislation at both

the federal and state levels, including the Federal Hawaii Tropical Forest Recovery Act and the State Forest Stewardship Act, Natural Area Partnership Program, Endangered Species Recovery Act, and Invasive Species Council. Mr. Buck also provided a leadership role in establishing Hawaii's Watershed Partnership Program.

Other relevant and notable positions held by Mr. Buck include Chair of the Council of Western State Foresters, Board member of the Western Forest Leadership Coalition, member of the Federal Invasive Species Advisory Committee, current Board member and Vice President for Investments of the National Association of State Foresters Foundation, and current Co-Chair of the National Roundtable on Sustainable Forests. In recognition of his significant contributions and knowledge in the field of forest management, Mr. Buck was a four time member of the United States delegation at the United Nations Forum on Forests.

Mr. Buck is presently a Sustainable Forests Representative for the National Association of State Foresters and a farmer in Waimanalo on the Island of Oahu.

He received his Bachelor of Science degree in Resource Management from the School of Environmental Sciences and Forestry, State University of New York, Syracuse and subsequently obtained a Master of Science degree in Forest Resources Conservation / Certificate of Tropical Agriculture from the Institute of Food and Agricultural Sciences, University of Florida.

Mr. Buck would bring to the Commission a valuable watershed perspective and many skills including innovative and proactive leadership, facilitation and conflict resolution, natural resource policy development, and knowledge in a diverse range of natural resource fields such as wildlife and watershed management, outdoor recreation, commercial forestry, invasive species, and conservation biology. The Department supports Mr. Michael Buck's nomination and appointment to the Commission on Water Resource Management.

I have also served on a non-profit board of directors with Mike Buck and know his attention to detail, dedication to public service, and creative and compassionate leadership style.

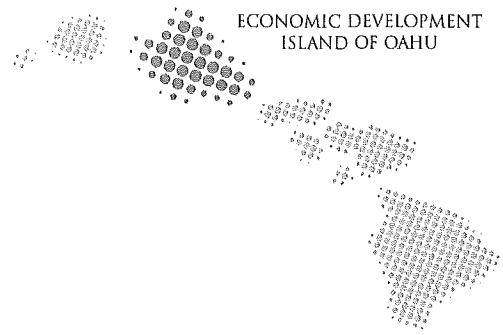

It gives me great pleasure to join the diverse community of people supporting Michael Buck's nomination to serve as a member of the Commission on Water Resource Management.



This is my testimony on the subject of confirmation of Mr. Michael Buck to serve as a member of the State of Hawai`i Water Commission at its hearing on April 14, 2014

I believe Mr. Buck to be unsuitable for a position as a member of the Water Commission that emphasizes the public trust regarding the environment and natural heritage of our state, protected for the benefit of all of our citizens.

While he headed the Division of Forestry and Wildlife in the 1990s, Mr. Buck abused or failed to represent this trust on more than one occasion. For example, in 1993, after a meeting on the Big Island, he sided with a handful of local hunters when he agreed to remove a fence, newly installed with public funds. The fence would have excluded forest-destroying feral pigs from parts of the Pu`u o `Umi Natural Area Reserve in the Kohala District on the Big Island. At the time, this NAR, extending around the headwaters of four major streams, was one of the richest and healthiest in the state, in terms of its native biodiversity. This episode suggests that Mr. Buck is prone to favor special interests in opposition to defending the public's natural and cultural resources. **[For documentation, please see: M. Engle, "State will remove feral pig fence after protests by Big Islanders," *Honolulu Star Bulletin*, March 11, 1993, p. A-5]**

Another example of Mr. Buck's inability to manage his public responsibilities arose between 2000 and 2002, when he was still head of DOFAW and in charge of proper management of the State of Hawai`i forestry resources. In this case the issue concerned the fate of the area around Pu`uwa`awa`a on the Big Island. A notorious state-lessee rancher had abused his lease and the landscape in a variety of ways, leaving the land in an overgrazed and partially deforested condition strewn with illegal dumpsites. At this point several conservation organizations applied to the state Land Board and DLNR for stewardship of the area with plans for reforestation and ecological rehabilitation emphasizing restoring native vegetation in what had once been one of Hawai`i's most biodiverse dryland forests. Early in 2002, one or more of the applicants that approached DLNR had the private funding at hand to begin these proposed works at Pu`uwa`awa`a. At this point, the Land Board rejected the private proposals and turned over responsibility for managing the lands in question to DOFAW, whereupon Michael Buck admitted that DOFAW was broke and that "It's going to make it a lot harder to get some of the matching funds to help us start planning for the habitat conservation plan." **[See *Environment Hawai`i*, Vol. 12, No. 11, p. 9]**

Examples like these, out of Michael Buck's former public-sector career lead me to believe that he is not fit to serve as a member of the State of Hawai`i Water Commission.

Chair Solomon and members of the Committee, thank you for the opportunity to appear before you today. I want to thank Governor Neil Abercrombie for nominating me. I truly consider this an honor and a privilege to be considered for this important position on the Commission of Water Resource Management. I want to also extend a warm mahalo to everyone that submitted letters of support on my behalf and to everyone here in attendance lending me their support and aloha. And finally to all the employees that I have worked with in my 28 years at the Department of Land and Natural Resources (DLNR) for all of their hard work and friendship.

I have followed the Water Commission's deliberations since its inception. While the debates about water use and allocation will never go away, the one area of consensus that all sides can agree to is that the natural systems (e.g. forested watersheds) providing our water should be maintained and enhanced. If this isn't done, there will be nothing to debate in the future. I encourage you all to read my introduction to *Wao Akua*, the tribute book for the Year of the Hawaiian Forest in 2003, celebrating the 100th anniversary of Hawai'i's Forest Reserve system. The history of forests and water in Hawai'i are intertwined, and will remain so. Ensuring the protection of Hawai'i's natural water-providing systems within the Commission framework will be a priority for me.

My interest in serving is also driven by a firm belief that water is key for connecting Hawaii's economic, environmental, and cultural values – the triple bottom line for sustainability. My professional experience and associations, both nationally and internationally, have reinforced for me that Hawaii is both a model and leader in water policy. I have learned over the years that we value what we use and we protect what we value, which I believe is a key concept to apply as we think about the sustainability of Hawai'i's water resources.

A key question that all prospective Water Commissioners should address is how to balance what are sure to be conflicting uses and pressures for Hawaii's water resources in your

decision making process. Hawaii's water law is an amalgamation of the ancient and historical Native Hawaiian water management system, surviving Kingdom law, and modern constitutional and statutory mandates. Water rights, exist in several forms and carry different obligations under the State Water Code and under common law. While I cannot comment on any specific pending Water Commission case, I believe there is clear guidance in statute and court decisions to provide a decision making framework that should be applied.

Hawaii is one of several states that have included the Public Trust Doctrine into its State Constitution. Article XI, Section 7, states, "*The State has an obligation to protect, control, and regulate the use of Hawaii's water resources for the benefit of its people.*" The application of the Public Trust Doctrine in resource management considers both the public's right to use and enjoy trust resources, and the private property rights that may exist in the use and possession of trust resources; however, any balancing between public and private interests begins with a presumption in favor of public use, access, and enjoyment. The Legislature incorporated the Public Trust Doctrine into the State Water Code as follows: *It is recognized that the waters of the State are held for the benefit of the citizens of the State. It is declared that the people of the State are beneficiaries and have a right to have the waters protected for their use.* (HRS §174C-2)

Hawaii's constitutional, statutory, and administrative rule provisions for protecting public interests was reinforced by the Hawaii Supreme Court decisions in the Waiahole Ditch Contested Case in 2000. The Court's decisions emphasize the Public Trust Doctrine and the associated Precautionary Principle as essential to the application and administration of the State Water Code. The Court decision also identified four trust purposes, three in the Waiahole Water Case, and a fourth in its 2004 Molokai decision. These trust purposes are equally protected under the law:

- Maintenance of waters in their natural state;
- Domestic water use of the general public, particularly drinking water;
- The exercise of Native Hawaiian and traditional and customary rights, including appurtenant rights; and
- Reservations of water for Hawaiian Home Land allotments.

The Court also identified the following principles for the water resources trust:

- The State has both the authority and duty to preserve the rights of present and future generations in the waters of the State;
- The State also bears the affirmative duty to take the public trust into account in the planning and allocation of water resources and to protect public trust uses whenever feasible;
- Competing public and private water uses must be weighed on a case-by case basis, and

any balancing between public and private purposes begins with a presumption in favor of public use, access, and enjoyment;

- There is a higher level of scrutiny for private commercial uses, with the burden ultimately lying with those seeking or approving such uses to justify them in light of the purposes protected by the trust; and
- Reason and necessity dictate that the public trust may have to accommodate uses inconsistent with the mandate of protection, to the unavoidable impairment of public in-stream uses and values; off-stream use is not precluded but requires that all uses, off-stream or in-stream, public or private, promote the best economic and social interests of the people of the State.

The Court's linking of the Public Trust Doctrine to the precautionary principle also offers significant guidance to water resource management as it establishes a general duty to take precautionary actions and thus shifts the burden of proof to non-trust purposes and requires preventive action in the face of uncertainty.

I recognize that this framework is not easy to implement. I know too well the challenges in choosing and balancing conflicting priorities and values within the context of the public trust doctrine associated with my nearly 3 decades of service with DLNR. I believe that the State Water Commission can do better. It is a reality that all major decisions by the Commission will probably face litigation. The goal of the Commission should be that its future decisions be sound and built on our established constitutional, statutory and judicial foundation --- and that they be affirmed, rather than remanded by the Supreme Court, as has too often been the case in the past.

Finding the right balance between protecting the public trust and being able to meet increasing future demands for water resources over a diversity of issues (in-stream flow standards, appurtenant rights, water re-use) will be challenging for the Water Commission. The 2000 Supreme Court Waiahole decision states, "*The constitutional framers and the legislature designed the Commission as an instrument for judicious planning and regulation, rather than crisis management*". I believe I can help the Commission to be this instrument by bringing a sense of integrity and responsibility that enables a diverse range of stakeholders to view and accept Water Commission deliberations and decisions as balanced, practical, and consistent with the law. The State of Hawaii has given me a lot and I look forward to giving back.

In closing, I would like to thank this Committee for the hard work you do for the State of Hawaii and for giving me the opportunity to be here today. Thank you for considering my nomination. Again, thank you to everyone who submitted testimony on my behalf and to those who are here supporting me today. At this time, I would be happy to answer any questions the Committee may have.
