It is with pleasure that the Department of Land and Natural Resources (Department) recommends Senate confirmation on the appointment of Thomas Oi to the Board of Land and Natural Resources.

The Board of Land and Natural Resource is established under Section 171-4, Hawaii Revised Statutes, and is composed of seven members, one from each of the four land districts, and three at large members. Mr. Oi has been nominated to represent Kauai County. Upon confirmation, Mr. Oi would start his term immediately as there is currently no sitting Board member from Kauai. Mr. Oi's appointment would run through June 30, 2016.

Mr. Oi served as the Kauai District Land Agent for the Department's Land Division for over eight (8) years before retiring in 2011. He is currently employed by Representative Dee Morikawa during the Legislative Session. Prior to working for the Department, Mr, Oi worked as a Land Boundary Surveyor with the Department of Accounting and General Services and the Department of Transportation. He also has 15 years with a private engineering firm.

Outside of his professional discipline, Mr. Oi coached Lihue softball for ten years and currently serves on the Board of the Lihue Hongwanji.

The Department believes that Mr. Oi's extensive land surveying experience and familiarity of land management practices, will be a welcome addition to the Board of Land and Natural Resources. The Department greatly appreciates your consideration of Thomas Oi and strongly recommends his confirmation to the Board of Land and Natural Resources.

Being born and raised in Palolo and attending the public school system and living on the island of Kauai for over 40 years I consider myself a person with the old local philosophy to assist when help is needed.
