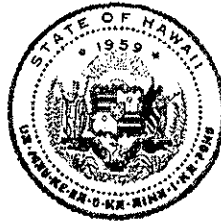
I am Doug Mayne, Vice Director of State Civil Defense. I am testifying in **FAVOR** of House Bill

Chairs Dela Cruz, Espero, Wakai and Ige, Vice Chairs Slom, Baker, Nishihara and Kidani, and Members of the Committees on Economic Development, Government Operations and Housing, Public Safety, Intergovernmental and Military Affairs and Technology and the Arts and Ways and Means.

The High Technology Development Corporation (HTDC) offers **comments** on HB 1280 HD2 Proposed SD1 relating to Public Safety. HTDC supports innovation and technology development in any industry, including for first responders and cyber security. HTDC has a core competency in technology and manufacturing and, under its 206M statutes, has the ability to develop technology parks.

Though we support the intent of HB 1280 HD2 Proposed SD1, HTDC will need \$800,000 for preliminary efforts to research and build expertise in this focus area, plan and work with the community to create the programs and content of the tech park, explore partnership opportunities, and solicit proposals to ensure the best use of State resources. This would be a specific appropriation and should not replace or adversely impact the Administration's budget request. Without an appropriation HTDC suggests that our agency would be best suited in a support role for this initiative, as part of a planning committee providing expertise in establishing technology parks and in entrepreneurship, rather than a revision of its 206M HRS.
