I am hoping for definite assurances that the Office of Hawaiian Education will definitely be **established**, that the Office of Hawaiian Education will be headed by an **Assistant Superintendent**, and that the Office of Hawaiian Education will be within the **Office of the Superintendent of Education** as a member of the **Superintendent's leadership team**. Your full support of HB 1551 would take the DOE Board Policies 2104 and 2105 to a much higher level, give them more "weight", and assure implementation of highest integrity and caliber.

My understanding is this new office would oversee, provide services, and fully support all Hawaiian Education programs in our public schools. I am certainly looking forward to having our curriculums revised, with appropriate

standardized assessments, etc., with on-going teacher/kūpuna/mākua development and In-Services as we all strive toward excellence in our Hawaiian Education Programs which include the K-6 Kūpuna Component, Middle and High Schools which offer Hawaiian Language, History, Culture, Arts, and Music, the Hawaiian Language Immersion Schools, and the Hawaii-Education based Charter schools.

I am trusting that the Office of Hawaiian Studies led by an Assistant Superintendent, with said Office being within the Office of the Superintendent of Education as a member of the Superintendent's team will become a "REALITY" in SY 2014-2015.
