Comments: I believe that the implementation of 980 instructional hours. Although, some schools have met the 1080 instructional hours, many schools have not achieved that goal yet. Allowing for the Board of Education to redefine "student instructional hours" would create new means of meeting student instructional hours. Various projects like Senior Project or History Projects should all be included as "student instructional hours". This allows for schools and students to meet the required amount of "student instructional hours". Good afternoon, Senator Tokuda, Senator Kidani, and members of the Senate Education Committee!

My name is Michelle Fortunato. I am a junior at Kalaheo High School and the Treasurer of Student Government.

It is a pleasure to be here this afternoon and speak to you of my support of House Bill 1675. As it stands right now, all Hawaii public schools are under the obligation to provide a minimum of 1080 instructional hours to their students. As you are surely aware, many schools are struggling to meet this requirement. And it is for what purpose? The initial leap from 915 hours to 1080 added approximately five minutes to each class period. It is hardly imaginable that this would have any substantial effect on students' learning. Despite this, the labor cost of this decision was exponential.

Unarguably there should be some baseline minimum for instructional hours. Otherwise the school board will first and foremost be concerned with monetary facets of the decision and number of school hours will greatly diminish. And there needs to be some degree of consistency between schools. But are more hours necessarily better? Students need to be balanced in their academics as well as their extracurricular activities.
