## SUBJECT: H.B. 1693, H.D.1 - RELATING TO HUMAN SERVICES

**<u>PURPOSE</u>**: The purpose of this bill is to require the State to pay interest on late

payments to an operator of an adult day care facility, community care foster family home, or adult residential care home.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS)

respectfully opposes this bill.

The current Med-QUEST Division contracts require that health plans pay 90% of claims within 30 days and 99% of claims within 90 days. For the quarter ending September 30, 2013, 95.6% of claims were paid within 30 days and 99.7% were paid within 90 days; for the quarter ending December 31, 2013, 92.8% of claims were paid within 30 days and 99.3% were paid within 90 days. The total amount of interest paid by QExA plans for claims paid over 30 days was \$91.84 for October 1, 2013-December 31, 2013.

Additionally, the current law provides equitable treatment for all vendors contracted with the State related to late payments. All providers are important as they provide vital services for the Department's recipients, however, DHS opposes preferential treatment for operators of an adult day care facility, community care foster family home, or adult residential care home.
