HB 1714 HD1 - RELATING TO CLIMATE CHANGE.

Chairs Gabbard and Solomon, Vice Chairs Ruderman and Galuteria, and Members of the Senate Committees assembled; the University of Hawaii is in favor of HB 1714 HD1, which establishes the Interagency Climate Adaptation Committee under the Department of Land and Natural Resources with the task of creating a sea-level rise vulnerability and adaptation report and tasks the Office of Planning with establishing and implementing strategic climate adaptation plans and policy recommendations based on the report.

Climate change has become a dangerous, socially disruptive reality that threatens the future sustainability of life in the Hawaiian Islands. By developing an interagency climate committee to report on the issue of sea level rise, you will be taking a strong step toward achieving maximum protection of public health and safety as well as protection of natural resources for future generations.

In 2012 the National Academy of Sciences projected that global sea level will rise 3 to 9 inches by 2030, 7 to 19 inches by 2050, and 20 to 55 inches by 2100. In 2013 they published a report indicating that greenhouse gases emitted today will cause sea level to rise for centuries to come. Each degree of global warming is likely to raise sea level by more than 6 feet in the future. Note, that global temperatures have already risen 0.9 degrees.

By developing a strategic plan for guiding statewide growth in the context of rising sea levels, you will be taking a strong step in protecting the public from one of the most dangerous aspects of climate change as manifested in the Hawaiian Islands.

Researchers at the University of Hawaii stand ready to assist the committee in their work.
