Chairs Nishihara and Baker, Vice Chairs Kouchi and Taniguchi, and Members of the Committees.

The Department of Business, Economic Development, and Tourism (DBEDT) supports amending the fuels specification standards to align with those currently set by the American Society for Testing and Materials (ASTM) and Society of Automotive Engineers (SAE).

HB 1938 is in response to a finding of the Refinery Task Force Interim Report as reported to Gov. Abercrombie on November 15, 2013, calling for modification of Hawaii's gasoline specifications to mitigate the impacts of a potential refinery closure. This is a housekeeping measure addressing inconsistencies in Hawaii gasoline specifications, current overall U.S. requirements and other laws and administrative rules in effect in Hawaii.

This measure also updates rules adopted by the Department of Business, Economic Development & Tourism in 2006 and fuel specification rules currently in effect under the Department of Agriculture. The state law requiring a 10% blend ethanol blend for motor gasoline was adopted into statute to promote the agriculture industry in 1994. Subsequently, DBEDT adopted administrative rules requiring 85% of all motor gasoline distributed in Hawaii contain 10% ethanol (E10). The Department of Agriculture fuels specification rules were not updated to current/accurate ASTM standards and therefore it is not feasible to comply with both the outdated fuel specifications and the current ethanol mandate.

We support Chevron's amendment to change to the specific ASTM reference.

Thank you for the opportunity to offer these comments on HB1938.

House Bill 1938: Relating to Measurements Standards

Aloha Chair Nishihara and Vice Chair Kouchi, Chair Baker and Vice Chair Taniguchi, and members of the Senate committees on Agriculture and Consumer Protection & Commerce,

We are writing in support of House Bill 1938 and to propose amendments to the bill.

HB 1938 is intended as a housekeeping measure and provides that current standards as published by the American Society for Testing and Materials and the Society for Automotive Engineers are adopted for use by the Measurement and Standards Branch of the Department of Agriculture. This bill seeks to clarify Section 486-56, Hawaii Revised Statues, by adding the word "current" to the existing language of law.

This bill is necessitated by an inconsistency between rules adopted by the Department of Business, Economic Development & Tourism in 2006 and fuel specifications rules then (and now) in effect under the Department of Agriculture.

The state law requiring a 10% blend ethanol blend for motor gasoline was adopted into statute to promote the agriculture industry in 1994, 20 years ago. Subsequently, DBEDT adopted administrative rules requiring 85% of all motor gasoline distributed in Hawaii contain 10% ethanol (E10) was adopted by DBEDT. Allowing for an 18-month transition period, E10 was started in Hawaii in April 2006.

The Department of Agriculture fuels specification rules were not updated to current/accurate ASTM standards and therefore it is not feasible to comply with both the outdated fuel specifications and the current ethanol mandate.

Governor Neil Abercrombie's Refinery Task Force has discussed the inconsistency and recommended that revisions be made to update the fuel specifications. Members of the industry have been requesting just such a change dating back over half a dozen years.

It is crucial that Hawaii gasoline specifications be consistent with current overall U.S. requirements and with other laws and administrative rules in effect here in Hawaii.

This bill references the "current" ASTM specifications. We respectfully propose an amendment to confine the change just to that which is necessitated by the ethanol blending mandate – the specific ASTM reference, ASTM D4814, noted below and in the interest of clarity to specify that the 2013 version is adopted.

"The <u>current</u> standards is published by the American Society for Testing and Materials (ASTM) and the Society of Automotive Engineers (SAE) are adopted except as amended or modified by rule of the board pursuant to chapter 91. The board may also adopt rules on the advertising, labeling, standards for, handling, storing, dispensing, and selling of petroleum products.

Notwithstanding the foregoing, rules adopted by the board specifically referring to ASTM D4814 shall be deemed to refer to the version ASTM D4814-13b adopted in 2013, as modified by the version of NIST Handbook 130, Part G, Section 2.1 adopted in 2013."

SECTION 2. Statutory material to be repealed as bracketed and stricken. New statutory material in underscored.

SECTION. This Act shall take effect upon its approval."

We look forward to participating collaboratively with the legislature and stakeholders to address the inconsistency currently existing between the DBEDT and Department of Agriculture rules.

MidPac is writing to support H.B. No. 1938 and to propose amendments to the bill. We understand HB No. 1938 to be a housekeeping measure which seeks to clarify Section 486-56 of the Hawaii Revised Statutes by adding the word "current" to the existing language of the law to provide that the Measurement and Standards Branch of the Department of Agriculture adopt for use the "current" standards, as published by the American Society for Testing and Materials ("ASTM") and the Society of Automotive Engineers.
