TESTIMONY OF THE STATE FOUNDATION ON CULTURE AND THE ARTS TO THE SENATE COMMITTEE ON TECHNOLOGY AND THE ARTS on March 11, 2014

HB 2593 HD1

RELATING TO URBAN ART.

Chair Wakai and members of the committee, I am Barbara Saromines-Ganne, Chairperson of the Commission of the State Foundation on Culture and the Arts (SFCA) and I am pleased to testify in support of HB 2593 HD1.

Urban art, which includes graffiti and tagging, is a form of social commentary, a vehicle of personal expression by young generations of city youth who are continuously looking for ways to have their voices heard. HB 2593 HD1 attempts to provide a creative alternative for youth that ultimately benefits their communities. Offering a program in urban art is a viable solution by government in the spirit of public murals and street art, which have successfully engaged urban populations and diverse audiences in communities around the world.

We are advised that a task force studied the climate and identified conditions and spaces in which youth can work. We are fully supportive of individual State departments working with the SFCA in this process, including the department of accounting and general services, the department of land and natural resources and its historic preservation division, and any other stakeholders deemed appropriate. Collectively, we welcome the opportunity to discuss how the outcomes can be efficiently assessed. We also hope to continue this dialog about a more permanent solution that bridges the creative expression of our youth with the discovery of art in all of its diverse and wonderful forms.
