Chair Ige and Members of the Committee:

This bill requires the University of Hawaii sea grant college to prepare and submit a report updating the 1996 report entitled "Hawaii's Readiness to Prevent and Respond to Oil Spills," which report is to include findings, recommendations, and proposed draft legislation, if necessary, no later than twenty days prior to the convening of the regular session of the Legislature in 2016.

Article X, section 6, of the Hawaii State Constitution, gives the University of Hawaii Board of Regents "exclusive jurisdiction over the internal structure, management, and operation of the university." Section 6 further provides that: "This section shall not limit the power of the legislature to enact laws of statewide concern. The legislature shall have the exclusive jurisdiction to identify laws of statewide concern."

The legislature should consider amending this bill to add a provision identifying the bill to be a law of statewide concern.

8 greatly shaped Hawaii's ability and capability to respond to potential oil spills in Hawaiian waters. The

9 proposed updating of this evaluation will further strengthen Hawaii's preparedness and response

10 program to better plan for potential harmful releases to Hawaii waters and land with current knowledge

and technologies. As the economy strengthens and energy sources dynamics change, it is critical that

12 our planning be updated to prevent environmental pollution and protect public health.
