The Department of Commerce and Consumer Affairs ("Department") appreciates the opportunity to testify on House Concurrent Resolution No. 66, Requesting the State Auditor to Conduct a Sunrise Review of the Regulation of Veterinary Technicians and the Practice of Veterinary Technology. My name is Daria Loy-Goto, Complaints and Enforcement Officer for the Department's Regulated Industries Complaints Office ("RICO"). RICO offers the following

testimony in support of the concurrent resolution. RICO notes that this Committee heard the companion concurrent resolution, Senate Concurrent Resolution No. 46, and passed out that concurrent resolution without amendments.

House Concurrent Resolution No. 66 requests a sunrise review by the Auditor on the regulation of veterinary technicians as proposed in Senate Bill No. 2502 S.D.1. RICO supports a sunrise review in accordance with §26H-6, Hawaii Revised Statutes.

RICO has been working collaboratively with the Board of Veterinary

Examiners and the Hawaii Veterinary Medical Association on the enforcement

provisions in Senate Bill No. 2502 S.D.1, with the understanding by all parties that
the bill's proposed registration scheme would be the subject of a sunrise review.

My name is John Kaya, D.V.M., and I am the Chairperson of the Board of Veterinary Examiners ("Board"). Thank you for the opportunity to present testimony in support of House Concurrent Resolution No. 66, Requesting the State Auditor to Conduct a Sunrise Review of the Regulation of Veterinary Technicians and the Practice of Veterinary Technology.

The Board understands that Section 26H-6, Hawaii Revised Statutes, requires that new regulatory measures being considered for enactment be referred to the Auditor for a sunrise analysis. Referral shall be by concurrent resolution that identifies a specific legislative bill to be analyzed. The statute further requires that the analysis shall set forth the probable effects of regulation, assess whether its enactment is consistent with the legislative policies of the Hawaii Regulatory Licensing Reform Act, and assess alternative forms of regulation.

The Board worked with the proponents of the bill and compromise language was reached, and Senate Bill No. 2502, S.D. 1, is the bill to be analyzed by the Auditor.

Affected parties are in full support of establishing requirements for the regulation of veterinary technicians and the practice of veterinary technology.
