Guideline Criteria and Procedure

The HSBA utilizes the following guideline criteria, patterned after the American Bar Association Guidelines for Reviewing Qualifications of Candidates for State Judicial Office, in its deliberations when reviewing a judicial nomination: integrity and diligence, legal knowledge and ability, professional experience, judicial temperament, financial responsibility, public services, health, and responsibilities and duties required of the position for which the applicant has been nominated.

The HSBA Board has a rating system with two (2) categories: "qualified" and "not qualified". The qualification determination is an advisory rating for consideration by the Senate, the confirming authority for those nominated to serve on the State's Bench. The determination of "qualified" or "not qualified" is made by the HSBA Board after a review of the Judicial Selection Commission (JSC) application and the HSBA's own questionnaire. It should be noted that in some areas, the HSBA questionnaire seeks a broader range of information than the JSC. For example, in the area of attorney discipline, the JSC asks the judicial applicant if he/she has been the subject of any "disciplinary action". The HSBA questionnaire asks the applicant if he/she has ever been involved in a "disciplinary proceeding".

In addition to the written documentation submitted by the nominee, references also provided by the nominee are contacted, and a review of comments, positive as well as negative, offered by Bar members is undertaken. The HSBA Board then interviews the nominee.

Procedure and Process Review

The HSBA Board has, since the most recent Judiciary and Labor Committee hearing, reevaluated the judicial nomination review procedure. ALL active members will receive notices of judicial nominations and the solicitation of comment, including notices of comment solicitation for judicial retention and mid-term evaluation purposes. HSBA members will no longer be allowed to "opt out" of these types of e-mail communications. Nominees will be apprised of any areas of concern at least 24 hours prior to the Board's interview of the nominee.

The entire procedure including the receipt of and reliance on confidential comments is being reviewed.

Conclusion

After reviewing the documentation provided by Mr. Nakamoto and comments from members, contacting the references provided, and meeting with the nominee, the HSBA Board finds Henry T. Nakamoto QUALIFIED for the position of District Family Court Judge for the Third Circuit.
