I am Larry Lawson, Acting Major of the Wahiawa Police Station, District 2, Honolulu Police Department (HPD), City and County of Honolulu.

The HPD opposes Senate Bill 2025. Senate Bill 2025, in its current form, would restrict the HPD from taking into account all the facts of an incident and making a reasonable assessment to issue a 48-hour stay away order.

Senate Bill 2025 is worded that the HPD "shall" issue a 48-hour stay away order in all cases where abuse or harm occurred regardless of when the abuse or harm occurred. It also removes the preamble of section 4(b) that refers to the person who is to be removed from the dwelling.

The HPD requests that your committee oppose the passage of Senate Bill 2025.





RE: SB No. 2025 - RELATING TO THE PENAL CODE

Dear Chair Espero and Members of the Committee:

The Maui Police Department supports SB No. 2025, with reservations. This bill requires police officers to make reasonable inquiry of family or household members upon whom the officer believes physical abuse or harm has been inflicted, and lawfully shall order the person to leave the premises for a period of 48 hours.

While the Maui Police Department supports the premises of increasing the no-contact period to 48 hours for the protection of abuse victims, we would like the 48-hour period to be further clarified.

According to the current version of this bill, when an incident occurs on any Saturday, Sunday, or legal holiday, the 48-hour period shall be enlarged and extended until 4:30 p.m. on the first day following the weekend or legal holiday.

If a person is issued a warning citation on a Sunday, this would suggest that the warning citation would expire on Monday at 4:30 p.m., and would not provide the full 48-hour protection for victims. A warning citation issued to a person on a holiday, which falls on a day not adjacent to a weekend would also fall into a similar situation.

The Maui Police Department suggest that the bill be revised to state that, if the incident occurs after 12:00 p.m on Friday, or on any Saturday, Sunday or legal holiday, the 48-hour period shall be enlarged and extended until 4:30 p.m. on the second day following the weekend or legal holiday.
