I would like to express my approval of the proposed bills 2938 & 2050. Making the registration process more streamlined is an excellent idea. Currently, individuals purchasing/registering handguns have to take a minimum of 2 days off from work in order to stand in line to obtain and submit paperwork, pick up paperwork (days later) and finally return to present the firearm for registration. This timeframe assumes that you can make the limited office hours, find parking and that the line isn't too long. The situation doesn't change.. no matter how many firearms you have already registered.

Comments: Officers Kealoha and Nitta from HPD apparently misunderstand SB2050. It does NOT relinquish current firearm owners from the necessity of a background check. It merely eliminates the two to three week waiting period to conduct such a check. Most states use the NICS background check system to do "instant" background checks and there is no evidence that using such a system has any impact on crime rates. The two week to three week "waiting period" in Hawaii serves no useful purpose for conducting checks when they can be done in minutes or less and be just as effective in screening prohibited persons.'
