SB 2052 — Relating to the Hawai'i Rules of Evidence

My name is Debbie Boyd, Executive Director, Risk Management for Hawai'i Pacific Health (HPH). HPH is a nonprofit health care system and the state's largest health care provider anchored by its four nonprofit hospitals: Kapi'olani Medical Center for Women & Children, Pali Momi Medical Center, Straub Clinic & Hospital and Wilcox Memorial Hospital on Kauai. HPH is committed to providing the highest quality medical care and service to the people of Hawai'i and the Pacific Region through its four affiliated hospitals, 49 outpatient clinics and service sites, more than 5,400 employees and 1,300 physicians on staff.

I am writing in support of SB 2052 which would establish that statements or conduct that express apology made by a health care provider concerning an unanticipated medical care outcome are inadmissible to prove liability for any claim resulting from that event.

We support this bill and its intent to strengthen the physician-patient relationship and reduce the number of unnecessary medical malpractice lawsuits. Passage of this measure will help facilitate candid conversation between health care providers and patient in the event of an unanticipated medical outcome.

We ask for your help and support in passing SB 2052 from this committee. Thank you.
