Senator Suzanne Chun Oakland, Senator Josh Green Vice Chair, and members of the Senate Committee on Human Services, my name is Marty Oliphant. I serve as the Executive Director of the National Association of Social Workers, Hawai'i Chapter (NASW). NASW supports the intent of SB 2160 Relating to Failure to Report a Missing Child.

According to the U.S. Department of Justice, 797,500 children younger than 18 were reported missing in a one-year period of time...resulting in an average of 2, 185 children being reported missing each day. In addition, the Courage Worldwide website (courageworldwide.org/hawaii/the-problem/) states, "The discrepancy in the number of children reported as runaways and the actual number of children missing is often due to non-reporting. Approximately 300 to 400 children are reported missing everyone month in Hawaii. Children on the street, lacking basic human necessities, are most vulnerable and susceptible to sex traffickers". These statistics are mentioned to highlight the need of the caregiver to promptly report missing children. Outcomes for missing children are usually negative.

Once a caregiver is aware of a child's death, they should immediately contact the authorities. The medical interventions and/or determination should be handled by the appropriate medically trained professional. Immediate investigation of the circumstance of the child's death can prevent injury to potentially other children associated with the deceased child.

NASW supports the intent of the SB 2160 in that the measure would encourage immediate response of the caregiver regarding the death of child and/or missing child.

NASW urges your favorable consideration of SB 2160.
