Aloha Chair Solomon, and Members of the Committee:

I am Christopher Manfredi, President of the Hawaii Farm Bureau Federation (HFBF). Organized since 1948, the HFBF is comprised of 1,832 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

HFBF opposes SB 2273. HFBF works closely with the 16 SWCDs throughout the State of Hawaii, in fact many of our members serve on SWCD boards.

HFBF believes that the current voting process in Chapter 180-12 is operating as intended.

SB 2273 appears to be a solution in search of a problem.

HACD is unaware of the issues surrounding the proposed changes expressed in SB 2273. We further believe that HACD should be given the opportunity to understand and address the need for these amendments before changes to the law be proposed.

Therefore HFB opposes this measure and asks the committee to do the same.

Testimony in opposition of SB2273

Aloha Chair Solomon, Vice Chair Galuteria and fellow WTL Committee Members,

My name is Wes Nohara, I am the Legislative Chair for the Hawaii Association of Conservation Districts. We represent 16 Soil & Water Conservation Districts of Hawaii.

We took a poll of our 16 districts and the districts unanimously opposed to this proposed bill.

Hawaii is a unique state in that we vote for directors based on acres of landownership. This method has worked well for us since the beginning of our organizations (1945). We are not aware of the reason for this request or the problem or concern that that prompted this measure. If it is an isolated problem, we would prefer an opportunity to address the concern versus changing Chapter 180. Clearly, the majority of the districts do not support this request.

Of the 3,000 districts nationwide, there is no standard method of voting or appointing of directors. Every state determines the process that best serves their needs.

Chapter 180 HRS requires that 2 directors be appointed and 3 directors elected for 3 year terms each. We are concerned that this proposed change to the current election process, may create unforeseen problems for the 16 districts.

We believe one of the potential results could be higher turnover of directors. While this in itself may not be bad, the lack of funds to support and train directors could be seriously problematic. Currently, each district receives only about \$2,000 per year to handle all operational costs. Even with a fairly high level of experienced directors, we struggle to operate effectively. A high level of turnover and inexperienced directors could cripple our ability to serve our communities.

I have served the soil conservation movement of a Hawaii for about 28 years. It took me about 4 to 5 years of learning and training under great conservation leaders like Buddy Nobriga (Maui), before I became somewhat proficient and confident in my abilities. I began as an Associate Director (non voting). This is a very effective way to train directors on a shoe string budget -- A process that is highly recommended.

Rather than changing Chapter 180-12, we ask that the concerns that initiated this request be forwarded to us at HACD so that we can work to address those concerns. We welcome new blood and new ideas to help us into the future. We just don't think changing Chapter 180-12 is the best way to go about this.

We ask that those concerns or concerned individuals contact HACD so we can best address those concerns and respectfully request that this measure be HELD. Thank you for allowing me to testify on this matter.
