Chairpersons Solomon and Espero and Members of the Committees:

Thank you for the opportunity to testify on Senate Bill No. 2274. This measure requires the counties of Maui and the Big Island to establish permits for sustainable living research sites on areas less than 15 acres. The Department of Agriculture has concerns.

This bill seeks to create a new permit at the county level to establish what appears to be permanent "sustainable living research sites" that promote a live-in environment that emphasizes conservation, waste re-use, organic foods, renewable energy, and shared living. These sites are not to be subject to all county codes, ordinances, rules, or permits. These sites are to be permitted uses within the Agricultural District.

The Department of Agriculture supports efforts to increase food production and promote agricultural education. However, we are uncertain as to the role and magnitude that agricultural activities and uses will have in these "sustainable living research sites". We are very concerned that these sites may evolve into urban-like areas over time. We recommend the counties, as they develop their ordinances and



rules for sustainable living research site permits, carefully scrutinize land uses and activities proposed in this measure that are not specifically related to agricultural production and activities.

Dear Members of the Committee:

Real water conservation is currently illegal in Hawaii; SB2274, in its provision of experimental sustainability sites, would allow citizens to practice true water conservation.

Hawaii's health codes – like those of most jurisdictions in the United States – require either a septic tank or a sewer connection. Such codes, though their intentions are pure, have led to a waste disposal paradigm that can be described as water-intensive, money-intensive, energy-intensive and – worst of all – unnecessary. Many new home builders like myself would like to forego blackwater altogether and install composting toilets in their homes. However, because state codes both (a) require a sewer or septic connection anyway, and (b) disallow people from building their own composting toilets, instead forcing them to buy pre-approved models at 15x the price of a water toilet, many builders give up and install water toilets. SB2274, in allowing exemptions from such codes, would incentivize builders like me to set up composting by making it far more affordable to do so.

Hawaii's greywater code, while well-meaning, also provides a roadblock to water conservation. While other states like Oregon define all non-toilet water as "greywater," thereby allowing it to be returned to the land without government infrastructure (and therefore expense), Hawaii does not consider kitchen sink water to be greywater. Kitchen sink water must go into either a septic tank or the sewer lines. Here again, a builder is confronted with a legal requirement to create a septic or sewer connection; once such a connection is made, there is heavy incentive to hook everything else to it as well, since the connection / installation cost must be paid anyway.

It's unclear why Hawaii considers kitchen sink water to be blackwater. Food scraps can easily be filtered, removed and composted, if that is the concern. Most soaps actually provide nutrients to plants, but the point is often moot since people, especially on agricultural lots, wouldn't output anything in their greywater they even suspect might harm the health of their plants.

So there you have it: a paradigm in which no fecal matter ever touches water, water is never flushed down a toilet, and all water used in a household is returned immediately to the land. This paradigm is currently illegal, and SB2274 would make it possible. On behalf of myself and people like me who want a better, more affordable and more sustainable future, I plead that you pass SB2274.
