RELATING TO AGRICULTURE

Senate Bill No. 2292 authorizes the Director of Finance to issue general obligation bonds to fund irrigation infrastructure for the former Galbraith estate property.

The Department has technical comments on this bill. Federal tax law requires, among other things, that tax-exempt general obligation bond proceeds be used to finance projects that serve public purposes. As it appears that private entities may derive the benefit from this legislation, tax-exempt general obligation bond proceeds cannot be used for this purpose. The State would need to issue taxable general obligation bonds at a higher cost in order to allow the Department of Agriculture to provide financing assistance to private entities. In addition, as funding for these projects were not in the proposed Executive Budget, the annual debt service related to this proposed authorization of general obligation bonds should also be included in the Legislature's budget.

From a policy perspective, the Legislature should seriously consider the implications of using public funds to benefit private entities or private property owners especially for what is the appropriate threshold of public benefit for such appropriations.

Chairpersons Nishihara, Solomon and Members of the Committees:

Thank you for the opportunity to testify on Senate Bill No. 2292, a bill to authorize the director of finance to issue general obligation bonds in the sum of \$8,000,000 for the purpose of irrigation infrastructure for the former Galbraith Estate property. The Agribusiness Development Corporation (ADC) supports this measure.

ADC acquired approximately 1,207-acres of the former plantation with plans to transition these fallow lands into diversified farms. This bill will provide the corporation with the required capital to repair, rehabilitate, or reconstruct existing irrigation infrastructure. At this present time, the Galbraith land does not have an irrigation system compatible with today's diversified agricultural farming operations.

Many factors make farming in Hawaii more difficult. Often, the lack of a proper water delivery system hinders the delivery of water for efficient production. Installing

proper drainage, replacing inefficient ditches, and having facilities capable of efficiently supplying water at both high and low flows on the Galbraith Land would result in greater efficiency and ensure our farmers have an adequate water source.

Because an efficient water system in agriculture is critical to increase agricultural production, ADC respectfully requests that the Committees pass this bill.


Aloha Chairs Nishihara and Solomon, Vice Chairs Kouchi and Galuteria, and Members of the Committees:

Dear Chair Nishihara, Vice Chair Kouchi, Chair Solomon, Vice Chair Galuteria and Members of the Committees:

My name is Kyle Datta and I am general partner of the Ulupono Initiative, a Honolulu-based impact investment firm, which is working to improve the quality of life for Hawai'i residents by investing in projects that create more locally grown food, increase renewable energy and reduce/recycle waste. We are representing on behalf of the Local Food Coalition, which is an organization comprising farmers, ranchers, livestock producers, investors and other organizations working to provide Hawai'i's food supply.

The Local Food Coalition strongly supports SB 2292, which authorizes the director of finance to issue general obligation bonds to fund capital improvements for the former Galbraith Estate lands, which will enable significant agricultural expansion on Oʻahu.

The recent acquisition of the 1,200 acres of Central Oʻahu farmland offers an opportunity for agricultural growth on the state's most populated island, providing an opportunity to grow more food for our community, protecting agricultural lands and helping to make our state more self-sufficient in producing our own food. LURF's mission is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources, and public health and safety.

LURF appreciates the opportunity to express its **support of SB 2292**, and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations and the conservation and protection of agriculture, including important agricultural lands in Hawaii. The bill conveys the need for collaboration amongst diverse sectors of the community - business, government, and agricultural stakeholders - and the importance for them to work together cooperatively to improve the economic viability of the State's agricultural industry.

SB 2292. This bill proposes to authorize the director of finance to issue general obligation bonds to finance irrigation infrastructure for the former Galbraith Estate property now owned by the State.

LURF's Position. The purpose of this bill is to provide additional funding required for construction of necessary irrigation infrastructure, including electrical, irrigation, roads, and other capital improvements, for the former Galbraith Estate property, which was acquired by the State for agricultural use, and which will help increase local agricultural production.

With large amounts of prime agricultural lands and irrigation systems made available for conversion to diversified agriculture through acquisitions of property formerly used for

large-scale agricultural operations, the State presently has an opportunity to strengthen and expand Hawaii's diversified agriculture industry. However, redevelopment of these agricultural lands, including construction of irrigation infrastructure, is required to supply the significant quantities of water needed to support and maintain productivity. In order to ensure that local agricultural producers who utilize these lands may continue to receive a dependable supply of water for crops, as well as research and development operations, sufficient funding is necessary to construct these irrigation improvements.

Local farmers and ranchers who rely on irrigation systems to service their agricultural lands consider such resources critical to conduct their agricultural operations and to sustain their businesses. Agricultural stakeholders believe SB 2292 will greatly assist by providing funding necessary to construct necessary irrigation systems for the long-term betterment of the State's agricultural industry, and are relying on measures such as this to help them work toward the expansion of diversified agriculture; promote the agricultural self-sufficiency of the State; and to protect water as an important resource.

For the above reasons, LURF **supports SB 2292**, and respectfully urges your favorable consideration.

Aloha Chairs Nishihara and Solomon, Vice Chairs Kouchi and Galuteria, Senators, and other readers

The 2012 legislature appropriated \$750,000 to plan and design an irrigation system to irrigate the Galbraith lands. A recent online search of the State Procurement Office "Contract Awards & Info" suggests that a contract for this work has not been awarded. It seems to me that a request to issue eight million dollars in general obligation bonds should be based upon a reasonable assessment of how the funds would be spent, and that such an assessment would be readily accessible to legislators and other taxpayers. What was the fate of the 2012 legislative appropriation to plan and design an irrigation system, and where is the plan and design documentation that justifies the expenditures proposed in SB2292?

In the process of planning, designing, building, and operating an irrigation system to irrigate the Galbraith lands, it may be essential to emphasize that (1) the irrigation project be conducted as a joint effort of the Agribusiness Development Corporation and the Office of Hawaiian Affairs, and (2) the irrigation system function to provide rightful and equitable supplies of water to the lands controlled by each entity and to the farmers using the water.
