- 1 Department's Position: The Department of Health supports the intent of this measure and
- 2 recommends ammendments.
- 3 Fiscal Implications: The proposed measure will not change the amount of money collected
- 4 under the Electronic Waste and Television Recycling and Recovery Act. The proposed measure will
- allocate a percentage of the annual fees collected by the department to each county to pay for recycling
- 6 electronic devices.
- 7 Purpose and Justification: The department supports the intention of this bill as it aims to
- 8 improve the current Electronic Waste and Television Recycling Program by setting a convenience
- 9 requirement for electronic device manufacturers. This bill would require electronic device
- manufacturers to provide a convenient location in each county to accept electronic devices for
- recycling that shall be open a minimum of one day per week. However, this bill only amends HRS
- 339D-4, the section on electronic device manufacturer responsibility. This bill should also amend

Section 339D-23, the section on television manufacturer responsibility to include the same convenience requirement for television manufactures.

This bill also allocates a percentage of the annual fees collected to be distributed to the counties to pay for recycling electronic devices. The program currently contracts with the Hawaii, Maui and Kauai counties to assist in the collection and recycling of electronics. In FY 13 and FY 14, the program allocated \$100,000.00 to each neighbor island county for electronics collection and recycling. Annual registration fee revenues were \$320,000.00 for CY 2012 and \$330,000.00 for CY 2013.

The department currently does not provide support to the City and County of Honolulu for electronics recycling (as they declined the opportunity for funding). However, under this proposal the department would be required to provide the City and County of Honolulu a percentage of the manufacturer registration fees as indicated in statute. While the current draft of the bill does not indicate the percentages to be provided to each county, assuming that the distribution of the money will be based on population, future allocation to the neighbor islands would be drastically reduced. The department views the amendment to include in statute an allocation of the registration fees collected to each county as unnecessary since we already provide funding to each of the neighbor island counties.

The bill should leave allocations unspecified in statute, which would allow the department to continue re-distributing funds declined by the City & County of Honolulu to the neighbor island counties. The need for additional electronics recycling opportunities is greater on the neighbor islands. Oahu residents benefit from more electronic recycling opportunities relative to the neighbor islands because of the island's population concentration and lower shipping costs.

We look forward to working with the legislature and all interested parties while we remain focused on our goal to strengthen our electronics recycling law to enhance recycling opportunities and environmental protection.

SUBJECT: Senate Bill 2356: Relating to Recycling

The City and County of Honolulu's Department of Environmental Services (ENV) supports an amendment to the current statute that would further define the minimum requirements for the manufacturer-financed electronic waste recycling program. Senate Bill (SB) 2356 takes a partial step in requiring manufacturers to provide a convenient location in each county, but falls short in not additionally requiring the manufacturers to capture a specific portion, or market share, of the electronics sold within each county.

Under the existing law, manufacturers can submit a simple mail-back program, which is inadequate to generate any significant diversion of electronic waste from county landfills, and leaves the neighbor islands particularly under serviced. E-waste collection has been concentrated on Oahu, and even here recycling companies have complained that manufacturers do not provide adequate financial support.

We believe that the responsibilities for collecting and recycling electronic waste are best managed by the industry, and support the evolution of this law to strengthen those requirements.

On behalf of the Consumer Electronics Association® (CEA), I am writing to provide comments on SB 2356, which proposes to amend the existing statutes relating to the electric device recycling program.

CEA represents more than 2,100 companies involved in the design, development, manufacturing, distribution and integration of audio, video, in-vehicle electronics, wireless and landline communications, information technology, home networking, multimedia and accessory products, as well as related services that are sold through consumer channels.

SB 2356 would establish a formula for distributing proceeds from the manufacturer registration fees to Hawaii counties, and require that all manufacturer electronics recycling programs provide weekly collections in each county.

CEA recognizes the benefits achieved from the State's distribution of manufacturer registration fees to the counties. In 2013, a portion of manufacturer fees collected under the current state law were distributed to county recycling programs. This enabled county recycling programs to put out Request for Proposals (RFPs), for which various electronics recyclers put in no cost bids that were funded by one or more manufacturers. This system seems to be working for the neighbor islands, and CEA is open to formalizing the use of existing manufacturer registration fees to facilitate additional collections, particularly for the neighbor islands.

However, CEA has concerns that the weekly collection requirement in each county is impractical and excessive CEA therefore opposes the additional open-ended requirement proposed in the bill:

CEA Testimony Regarding SB 2356 Relating to Electronics Recycling January 29, 2014

Each electronic manufacturer shall provide a convenient location in each county to accept electronic devices for recycling that shall be open a minimum of one day per week;

If this requirement were implemented, it would require the 62 manufacturers currently registered under the state electronics recycling program to provide a weekly collection in each county. This requirement would be overkill. If the funding proposal in the bill formally establishes a distribution system by the State to the counties as is currently the practice, and manufacturers continue to subsidize recycler bids as they have been doing, this additional collection requirement is simply not necessary.

CEA remains committed to increasing education and awareness around recycling opportunities, and notes that CEA and its manufacturer members have worked over the past year to bolster collection opportunities by increasing collection events in Hawaii. CEA has also increased promotion and public outreach of its <u>Greenergadgets.org</u> website, which lists Hawaii e-waste collection locations by zip code, and has also recently, added a list of Hawaii collection events.

Re: SB2356 – Related to the Recycling of Electronic Devices

Recycle Hawaii is a non-profit 501(c)3 dedicated to promoting recycling and sound resource management. Since our founding in 1992, we have played a key role in the introduction of every major resource collection and waste prevention initiative the public currently enjoys, including state policy related to the recycling of electronic waste. Our experience with this component of the waste stream goes beyond politics, from 2004 through 2010 (the year the state electronics program went into effect), we were involved hands on, diverting over 2.3M pounds of electronics from the landfill. We know what works and what doesn't. The current program, through which manufacturers can fulfill their obligations by offering mailback opportunities, doesn't work.

SB2356 is needed to compel the manufacturers to offer opportunities that will promote and support the recycling of their products. We welcome the introduction of language that requires convenient drop-offs on each island and we urge this committee to pass the bill. We also support the allocation of funding in excess of program administrative costs in ways that increase the collection and diversion of electronic waste, but we feel that creating a county-by-county formula, especially one based on population, electronic device sales volumes or current recycling rates, is counterproductive.

Since the program began in 2010, the Hawaii State Department of Health has proven itself to be a responsible and honest broker in the process; we prefer to have these excess

funds allocated at the discretion of DOH, according to where they can have the greatest positive impact. Currently, the City and County of Honolulu is well-served by the collection programs established through the manufacturers plans while Hawaii County struggles to keep up with the demand for e-waste recycling services, especially in rural areas. A population based formula would direct funds where they are not needed.

Another consideration is the dynamic nature of the recycling industry; changes occur so rapidly that the public interest is much better served by giving regulators flexibility than by establishing provisions that can only be changed by legislation.

Finally, directing these funds to the counties decreases the likelihood of an eventual private sector takeover of the process. The public is best served when private industry provides recycling services; government's role is to create initiatives and incentives not compete with business. On Hawaii Island, we have a single private sector e-waste collector located in Hilo and open seven days a week from 7:30am to 5:30 pm, providing the service the public wants. . . e-waste collection any day of the week. If DOH were to provide private sector incentives with this excess funding rather than give it to the county to defray the costs of its once-a-month collections the public would be much better served.

Mandating the distribution of the funds to the counties is counterproductive. We therefore suggest that section (b) read thus: Annual fees collected for the electronic device recycling fund in excess of administrative costs shall be distributed at the discretion of the Department of Health for the purpose of increasing electronic recycling rates throughout the state.

Dell respectively must oppose SB 2356 as introduced. We are very proud of our proactive and aggressive efforts in the area of the environment, particularly in the area of electronic waste recycling. Unfortunately, we do not believe that SB 2356 is in the best interests of an effective recycling program in Hawaii for a number of reasons:

Mandatory Collection Centers

- The requirement for a mandatory collection facility in each county for each

 manufacturer would result in dozens of manufacturer collection sites in areas with low
 population and collection volumes. This would unnecessarily increase the already high
 costs of manufacturer collection, transportation and processing programs for electronic
 devices.
- The requirement for these centers to be open one day a week simply adds to the costs since the facilities would have to be leased, secured and managed 7 days a week, even though they would be open only one day a week.
- A better solution would be to provide an incentive for manufacturers to establish
 collection centers in higher cost, rural neighbor islands by providing 3X credit for each
 pound collected on those islands


Use of Manufacturer Registration Funds for County Recycling Operations

Manufacturers pay a \$5,000 fee each year to the Department to register their recycling
programs. The registration fee is set in the law at that level. The purpose of the fee
should be to cover the administrative costs to the Department to receive manufacturer
applications, review recycling programs, increase public awareness and enforce
requirements set forth in the law. Dell believes that the fee is adequate to cover those
administrative costs. The registration fees should not be used to subsidize the costs of

county recycling programs. Manufacturers assume all the costs of establishing and operating their recycling programs under Hawaii law. They should not assume the additional costs of government recycling programs over which they have no control of costs.

 A possible solution may be to offer an incentive to manufacturers for a credit per pound (e.g., 2x) for pounds manufacturers collect from county collection programs under mutually agreed to contracts between manufacturers and counties.

Dell cannot support SB 2356 as currently written. We believe that there are other solutions to resolve the concerns addressed by SB 2356. We look forward to working with the sponsors and the committee to ensure the success of Hawaii's electronic waste recycling program.

Thank you for the opportunity to convey my thoughts on SB 2356. I am writing to provide you with Sims Recycling Solutions' recommendations on the proposed changes to the existing Electronic Waste and Television Recycling and Recovery Act (Chapter 339D) that would be made as a result of SB 2356.

Background

Sims Recycling Solutions is the world's leading electronics recycler, with over 40 facilities in 14 countries. Sims Recycling Solutions has been an active participant in providing the citizens of Hawaii recycling services since the Act was implemented in 2010. We accomplish this by working closely with Pacific Corporate Solutions (PCS) of Aiea, HI. The services PCS and Sims Recycling Solutions provide meet the requirements established in the Act and are performed on behalf of a number of registered manufacturers of electronic equipment. Since the Act was implemented, the manufacturers who contract with Sims Recycling Solutions to provide collection and recycling services in Hawaii have been responsible for recycling almost 60% of the total reported volume of the program. They are also responsible for recycling over 1,000,000 pounds of additional television volume that does not show up on the Department's reports. The service Sims provides has collected unwanted electronics from the citizens of Hawaii of every county in the state. Sims Recycling Solutions is also providing similar take back service throughout the United States, Canada, and Europe. It is with this extensive experience that we provide the following suggestions in order to help to enhance the effectiveness and efficiencies of the take back system for the citizens of Hawaii.

SB 2356

SB 2356 is an effort to improve and fix some of the issues with the current electronic waste and television recycling program in the state. The issues were thoroughly discussed and analyzed during the Hawaii Electronic Device Recycling Task Force meetings the legislature directed the Department of Health hold in the fall of 2012. Sims Recycling Solutions was an active participant in the task force meetings. SB 2356 addresses a limited number of the issues that were brought

forward by the counties, the recyclers, the manufacturers, and the citizens of Hawaii. There are many other issues not addressed in SB 2356 that make the current law ineffective and inefficient.

Sims believes a comprehensive bill, addressing a whole range of issues, is a more prudent course of action. Introducing bills that address one or a limited number of issues at a time will create a piecemeal law and is not an efficient use of legislative resources.

Recommendation

Sims Recycling Solutions recommends the Senate focus their energy on the governor's bill, SB 2857. SB 2857 addresses a number of issues of the current law that were identified during the task force meetings. Though SB 2857, as currently written, does not "fix" all of the problems in the current program, it provides a substantial framework for the Senate to work from to make those needed improvements. SB 2857 has also been referred to the Committee on Energy and the Environment.

Thanks you for allowing Sims to provide you with these comments. We look forward to our continued participation to help improve the recycling opportunities to the citizens of Hawaii.
