#### In consideration of **SENATE BILL 2392** RELATING TO CONSERVATION EASEMENTS

Senate Bill 2392 proposes to amend the definition of conservation easement to include the preservation and protection of life and property from coastal hazards and inundation due to climate change and sea level rise. The Department of Land and Natural Resources (Department) opposes this bill.

The Department strongly supports the adaptation of existing conservation tools and programs to account for and counter the effects of climate change; however, the language of Senate Bill 2392 may allow the use of a conservation tool for non-conservation purposes. A conservation easement is a property interest held by public agencies and nonprofit organizations to protect natural, cultural, and agricultural resources on private lands for the public benefit. The reference to protection of "life and property" within Senate Bill 2392; however, appears to authorize the use of conservation easements to protect privately-owned coastal properties, effectively resulting in the use of public funds for a private benefit. The Department does support the protection of life and property as part of civil defense functions.

### THE TRUST FOR PUBLIC LAND'S TESTIMONY IN SUPPORT OF THE INTENT OF SB 2392 RELATING TO CONSERVATION EASEMENTS

Senate Committees on Water & Land and Energy & Environment Wednesday, February 12, 1:15 p.m., Room 225

The Trust for Public Land supports the intent of SB 2392 relating to conservation easements. This bill proposes to amend Hawai'i's conservation easement law to allow government and non-profit conservation organizations to hold conservation easements to preserve and protect life and property from coastal hazards and inundation due to climate change and sea level rise.

While the Trust for Public Land supports the intent of the bill to adapt to and mitigate the effects of climate change on our coastlines, the proposed amendment raises concerns. In general, the purpose of conservation easements is to protect resources important to the State of Hawai'i – for example, natural forested lands that produce our drinking water, historic and cultural sites that preserve our heritage, and agricultural lands that contribute to our food security. We are not aware of a conservation easement law that specifically authorizes the use of conservation easements to preserve and protect private property. In addition, climate change adaptation and mitigation is one of many important governmental conservation policies. There is no need to single out climate change in the conservation easement law over all other important conservation governmental policies such as protecting watershed that produce our drinking water, preserving habitat for rare species, conserving wetlands that provide flood control, or preventing soil erosion or runoff that will harm corals and nearshore marine waters.

We suggest the proposed amendment be changed to the following language to make it consistent with most conservation easement laws:

(5) Preserve or protect open space pursuant to a delineated federal, state, or local governmental conservation policy.

This language would allow non-profit land conservation organizations and government agencies to use conservation easements to address climate change, as well as other important governmental conservation policies. Although the Trust for Public Land supports the intent of this bill, I will not be able to appear in person to testify.
