The members of the Small Business Regulatory Review Board are **strongly opposed** to S.B. 2487 that would repeal chapter 201M, Hawaii Revised Statutes, the Small Business Regulatory Flexibility Act.

Act 168, codified as chapter 201M, Hawaii Revised Statutes established the small business regulatory flexibility act in 1998 which provided for a petition process to an agency for regulatory review, periodic administration review of rules which impacts small business, and the establishment of the independent regulatory review board.

This independent small business regulatory review board, better known as SBRRB, consists of eight pro-bono appointees from across the state each with different business backgrounds, and one designated DBEDT ex officio member, to provide a healthy, homegrown mixed plate representation of the 117,000+ small business entities throughout the state providing over 475,000 jobs.

We are frustrated and perplexed as to the introduction of S.B 2487 and the reasons cited in this bill stating "the legislature also finds that the small business regulatory review board has been going beyond the scope of its powers, as described under chapter 201M Hawaii Revised Statutes and is hindering the same administrative process it was originally intended to help. The legislature further finds that the small business regulatory flexibility act and small business regulatory review board have not functioned as envisioned."

The SBRRB of volunteers provide a valuable, needed service to enhance, promote and defend the continued growth of small businesses to perpetuate a positive, healthy economy and lifestyle for the benefit of our present and future generations here in Hawaii.
