Dear Chairs Espero and Chun Oakland and Committee Members:

Thank you for allowing me the opportunity to submit testimony in support of S.B. 2540 Relating to Housing in my capacity as Councilmember of the City and County of Honolulu.

S.B. 2540 establishes a rental deposit loan program within the Hawaii housing finance and development corporation to assist low income and homeless individuals and families in obtaining affordable rental housing. A rental deposit loan would help individuals and families living in temporary housing move on to permanent housing by eliminating the hurdle that is created by the high initial cost, security deposit plus first months rent.

Hawaii faces an ever increasing homeless population. This program would help those on the less vulnerable end of the spectrum move out of the homeless or transitional populations and into stable permanent housing.

For these reasons, I respectfully ask for your favorable passage of S.B. 2540 Relating to Housing and thank the Committees for allowing me to provide testimony.

#### **Testimony in Support**

Thank you for the opportunity to provide testimony in strong support of SB2540. This bill would create a rental deposit loan program within the Hawaii Housing Finance and Development Corporation. The program will assist many of our low income families, individuals including seniors, and even the homeless in accessing long term housing.

To begin, I am here today as a former board member of Housing Hawaii a nonprofit 501c3 that was created in 2005, to advocate for affordable rental and for sale housing in Hawaii. One of the organization's goals is to increase the number of affordable rental homes and renters in Hawaii. SB2540 is a bill that will do just that.

I'm sure that the members of both committees' are aware that Hawaii has a housing crisis. One of the factors contributing to this crisis is the federal poverty level, which for Hawaii is to too low when compared our state's high cost of living. Another factor and a barrier preventing families and individual from moving from less that adequate housing is the requirement by rental property managers and landlords that a prospective tenant pay in advance their first months rent as well a security deposit equal to the first months rent. For many or our low income residents this is a barrier which is very hard to overcome.

In reviewing this bill in detail I wish to comment on two provisions of the bill. Page 3, line 17, item (f) refers to a three party contract. This could prove to be very cumbersome. I believe that there should only be two parties, the tenant and the rental agent or landlord. The facilitator of the loan program need not be a party to any rental contract. Their relationship is only with the tenant for the loan amount.

The second provision I take issue with pertains to the loan repayment agreement on page 4, item (3), line 12, that the agreement not exceed 24 months. I believe that the repayment period for the loan should be extended 36 months. This would benefit the tenant by lowering the monthly payment amount.

In closing I would just add that this is a good bill, and if ever enacted will provide a realistic mechanism from removing the high out-of-pocket cost associated with relocating from inadequate housing to place that may be better suited to meet a families or individual's specific needs what-ever they may be, perhaps closer to a place of employment, a better school for their children, or a family member who my be providing child care services to the mother can work.

Once again thank you for allowing this testimony here today.

# **HSAC Supports SB2540:**

Good Morning Chair Espero, Chair Chun Oakland; Vice Chair Baker, Vice Chair Green; And Distinguished Committee Members. My name is Alan Johnson, Chair of the Hawaii Substance Abuse Coalition, an organization of more than twenty treatment and prevention agencies across the State.

The Hawaii Substance Abuse Coalition fully supports funding a rental deposit loan program to assist low income and homeless in obtaining affordable rental housing.

- Several thousand homeless people every year seek substance use disorder treatment for addiction. Many have lost financial and social support from their families due to past grievances during their addiction use. As seek supportive living in rental homes, such as clean and sober houses, to sustain and build upon their recovery, they lack the resources to pay rent until they can qualify for financial assistance.
- Most people from treatment have received substantial government resources for treatment. Given this investment into their treatment, a short term, small loan would go a long way to help people to establish a supportive network and sustain their recovery.
