RELATING TO PROCUREMENT

Chair Dela Cruz Vice-Chair Slom, and members of the committee, thank you for the opportunity to submit testimony on SB 2557. The State Procurement Office (SPO) does not oppose a feasibility study to replace the State Procurement Code with applicable federal procurement code, provided the legislature appropriate a minimum of \$500,000 to procure for the outsourcing services the SPO will require to achieve this study. A feasibility study will be an extensive undertaking, requiring expertise, staffing, and funding resources currently not available within the SPO.

The SPO respectfully notes the following observations in regards to this study:

The study must include a detailed examination and meticulous side-by-side comparisons of the Hawaii procurement environment, procurement related statutes and rules with the federal code, a determination of whether the switch to federal code is beneficial, and the challenges thereto. A study must also include an assessment of the logistical requirements and anticipated costs (monetarily and culturally, taking into account governance and infrastructure) of rewriting the Hawaii Code to adapt to the Federal Code. Adaptation not only affects State agencies, but all CPO jurisdictions. On receipt of appropriated and allocated funding for the report, the SPO must first procure for the respective consulting services which will reduce the time allocation and quality of the interim report.

The SPO respectfully notes the following observations in regards to the reality of a total replacement of the procurement code in HRS 103D:

- 1. There will be some federal code procurement requirements that are more restrictive than the current State procurement code which may slow down the procurement process and possibly limit competition.
- 2. The extent of the transition from one set of regulations to a new set will be immense for the departments to implement and manage. The effects will be seen in increased funding requests, change management, infrastructure requirements and training.
- 3. With Hawaii being one of the most decentralized States when it comes to procurement, a major concern will be to provide adequate training to personnel not familiar with the FAR, a much more complex regulation and standards to comprehend.
- 4. Federal code requires large amounts of reporting and metrics. While these are goals that the State intends to ultimately reach over time, the immediate requirement will burden the current infrastructure, require a large dollar funding, additional civil service staffing, staff reorganizations, increased salary requirements, and the development of multiple procurement data bases that will manage federal requirements such as past performance, small business administration, source selection, and vendor coding.
- 5. Training and governance will include FAR training with higher-level certification requirements, a help desk; changes to various other Hawaii statutes (such as the Labor and Construction statutes), Rules and County Charters referencing the new Code; and the creation of new policy, directives and procurement circulars to provide guidance.
- 6. An in-depth, long-term change management plan will need to be developed and implemented over this period as we move the state over to federal code. Additional funds for outsourcing to subject matter experts will be required.
- 7. HRS 103F, State procurement code that deals with Health and Human Services has not been included in the repealing of code per this bill. The implementation of federal code would directly contradict and be mis-aligned to the current 103F code, causing confusion and higher expectation of protests.
- 8. In order to ensure the replacement to federal code would stand, the Hawaii Legislature would need to commit to exclude themselves from submitting any future procurement
 code changes as this would morph the code back into a customized code specific to Hawaii, diminishing the original intent to follow federal code.

9. The bill repeals State Procurement code 103D. It is not clear whether the intention to repeal is immediate upon approval of this bill or whether it is repealed at the date of the final report of January 2016. Notwithstanding the former assumption, the achievement of a fully fledged federal code implementation across the State by the latter date is extremely remote.

The SPO is committed to working with State Legislature and Agencies to develop the best policy and procedures for procurement that allow for streamlining, efficiencies, innovation, cost control and fair and equal contracting opportunities across the State of Hawaii. The SPO recognizes the benefits of certain federal procurement laws with much of the current State code is aligned with the federal code. Further, the SPO intends to continue research to determine what code (whether it be state specific or federally aligned) would best benefit our State as a whole.

Notwithstanding the above, we also find it extremely concerning that although the Bill appears to simply call for a feasibility study, it in effect repeals chapter 103D HRS. We note, there is no reason and/or justification given to substantiate such action.

The 2013 Legislature formed a State Procurement Code Task Force charged with studying how, if at all, the state procurement process could be improved. This Task Force is also required to prepare and submit a report of their findings to the Legislature. Adopting the provisions in SB2557 prior to reviewing the Task Force' findings, is simply premature.

For these reasons, we respectfully urge that you reconsider SB2557 and HOLD it in Committee.
