RE: S.B. 2574 RELATING TO MEDICAL MARIJUANA – **IN OPPOSITION**

Aloha Chair Green, Chair Baker and members of the Committees. My name is Pam Lichty and I'm testifying in opposition to this measure on behalf of the Drug Policy Action Group.

S.B. 2574, which would add “board certified pain specialist physician” to the type of physicians qualified to issue written certifications for medical marijuana patients, is an attempt to address an unintended consequence of a measure passed in the 2013 session.

That bill, SB 642, CD1 attempted to address purported problems with Hawaii-licensed physicians flying in from out of state and certifying patients in the absence of the “bona fide physician-patient relationship” acquired by law. Also required in the law, is that the written certification “is based upon the physician’s professional opinion after having completed a full assessment of the patient’s medical history and current medical condition.” There has also been concern that some Hawaii-licensed physicians are seeing patients and issuing registrations in non-medical situations such as at musical festivals or at protest rallies.

In order to address these abuses, language was added to the law requiring that the physician must be a “primary care physician” (PCP). While we agree that the kinds of inappropriate certifications noted above are skirting the spirit and perhaps the letter of the law, we think that both the current language and the proposed new language create more problems than they solve. Soon after SB 642 passed, we became aware that there are many, many situations where patients do not have access to a primary care physician who is willing or able to issue the certification. Those unable to do so, include physicians affiliated with Kaiser Permanente and those working at Veteran Administration hospitals. Moreover, there is a shortage of primary care physicians on the Neighbor Islands. A further complicating factor is that there is no definition of a PCP in the HRS since it is primarily a term used in the insurance industry.

So the bill before you today is an attempt to add to the range of physicians permitted to issue certifications (keeping in mind that this does not involve prescriptive authority and there are no medications dispensed.) Unfortunately board certified pain specialist physicians are far rarer than even PCPs. Again, the Neighbor Islands are at a particular disadvantage. (I believe there are some 30 doctors state-wide who fall into this category.)

Additionally pain is not the only condition covered by our medical marijuana law. The specified conditions such as cancer, HIV, conditions with muscle spasms such as multiple sclerosis, and more are treated by a range of specialist physicians including ophthalmologists, oncologists, infection disease specialists and many more. To exclude these categories of physicians because they are not PCPs totally contravenes the intent of the law. Moreover, especially when stricken with a serious illness or with an ongoing chronic condition patients often, in effect, use these physicians as their primary care physicians essentially visiting them for all medical situations that may arise.

And the answer is not, as SB 2574 would do, to add to the specific lists of physicians that may do certifications. This would simply open the door to a laundry list of specialty physicians who treat patients with a wide array of the covered conditions.

As advocates for patients, caregivers and physicians for the last 14 years, we believe the most equitable remedy for all concerned is to delete the PCP revision entirely and revert to the original language of the law – which does not specify the type of physician who can certify but rather the type of relationship said physician must have with the patient.

If there are still concerns about misrepresentation among physicians, then perhaps it's the Hawaii Medical Board who should scrutinize the situation and develop tighter guidelines. As your Committees know, the medical marijuana program is transitioning to the Department of Health this year and will be housed there as of January 1, 2015. They are currently in the process of developing new administrative rules. Perhaps instead of changing the original language of the law, DOH could be somehow given the authority to more closely scrutinize the certification requests they receive from physicians. Or DOH could set up a committee to set the standard of practice and what would trigger an audit. They could also be empowered to make referrals to the Medical Board.

Incidentally the description of the bill in the hearing notice says the new language would begin on January 2, 2015 whereas in the bill itself that it takes effect "upon its approval."

We urge the Committees to delete the proposed language **and** the limiting language passed last year to restore the original wording of the law as enacted in 2000.

OPPOSE SB 2574 -Medical Marijuana

Aloha Chairs Green and Baker and Members of the Committees!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies for more than a decade. This testimony is respectfully offered on behalf of the 5,800 Hawai'i individuals living behind bars, always mindful that approximately 1,500 Hawai'i individuals are serving their sentences abroad, thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Native Hawaiians, far from their ancestral lands.

SB 2574 permits board certified pain specialist physicians to prescribe medical marijuana beginning January 2, 2015.

Community Alliance on Prisons opposes limiting the physicians who can recommend medical marijuana to relieve their patients' suffering.

The Medical Marijuana Program was enacted in 2000 as compassionate legislation to help our community members suffering from a variety of ailments.

As the caregiver to three terminally ill patients, I can honestly say that marijuana helped them all during the last months of their lives and enabled them to bid aloha to those they loved

instead of existing in a narcotic stupor. It made a tremendous difference to the patient and to the families and friends in providing closure.

We searched Hawai'i Revised Statutes for the definition of 'primary care physician' and could not find one. We see that as a problem.

We looked up 'board certified pain specialist physician' to understand the intent of this bill. The American Society of Regional Anesthesia and Pain Medicine states:

A pain management specialist is a physician with special training in evaluation, diagnosis, and treatment of all different types of pain. Pain is actually a wide spectrum of disorders including acute pain, chronic pain and cancer pain and sometimes a combination of these. Pain can also arise for many different reasons such as surgery, injury, nerve damage, and metabolic problems such as diabetes. Occasionally, pain can even be the problem all by itself, without any obvious cause at all.

We were then curious about the number of 'board certified pain specialist physicians' in Hawai'i nei. A cursory search revealed that there are not many of these specialists across the Hawaiian Islands. O'ahu has 37 pain doctors, with 33 board certified. There appears to be only a handful of pain specialists on our Neighbor Islands and we were not able to determine if they are board certified.

So adding such a restrictive provision makes it difficult, if not impossible, for the patient. This presents a problem for people who need the medicine to relieve their suffering. Would they now have to abandon the relationship they have with the doctor they know and trust to find a 'board certified pain specialist physician'? This contravenes the spirit and intent of this compassionate legislation and places a huge and stressful burden on a patient and/or his or her caregiver.

The last person for whom I was a caregiver was my friend Joe, who was in the last stages of bone cancer. His doctor recommended that he access medical marijuana despite Florida being a state with no medical marijuana program. When he was able to access the medicine, it made a huge difference in the quality of the last few weeks of his life. It was my honor to help him with the transition.

We humbly ask the committees to hold this measure and to please respect the spirit and intent of this compassionate law and not place another burden on our suffering citizens.

Oppose – SB2574 – Relating to Medical Marijuana

Dear Honorable Committee Chairs and Vice Chairs,

Big Island Americans for Safe Access opposes SB2574 because it does not adequately address the problem Act 178 created when it said that only primary care physicians (PCP) can certify a patient for medical cannabis. This bill does not address that deficiency and muddies the waters even further to insert board certified pain specialist physicians into the equation. Why bother doing this? In Big Island ASA's opinion this is a smoke screen preparing us to accept that a patient with chronic pain would be required to see a "pain specialist physician". Passing this bill as it is written is a slippery slope toward this unbeneficial end for patients.

Nothing other than having a licensed physician no matter what their specialty or general practice training should be the ones that qualify patients for cannabis medicine. Please do not insert politics into the equation and revert the wording back to the way it was adopted in 2000.

It is high time that the legislature after 14 years of neglecting patients needs step up to the plate and pass something that is meaningful and helpful to the patients. In the past good bills have been heard that were so altered that they actually did more to harm patients or have died for not being advanced by politically motivated or influenced committee chairs. The patients are following these events and we do not forget who is working in our interests.

The legislature should be hearing bills such as SB686 which substantially improves the lot of patients or one of the dispensary bills which are so greatly needed for island patients to have safe access and a selection of strains which treats various debilitating diseases and conditions. But none of that. We have to define another category of board certified pain management specialty which does absolutely nothing to advance our plight. No caring or compassion seems to be the game plan at the state legislature. It's business as usual where patients are hung up to dry. We are collateral damage or expendables. Simply deplorable.

Comments: To require physicians who prescribe medical cannabis to be board certified pain specialist physicians is costly and burdensome, and undermines the intent of Act 228 to compassionately provide patients access to medical cannabis for the relief of debilitating medical conditions. Board certified pain specialist physicians are not readily available in Hawaii and many work for institutions with policies contrary to the intent of Act 228. Furthermore, to require physicians who prescribe medical cannabis to be primary care physicians is problematic for many qualifying patients who go to Kaiser or the VA. I do not support this bill as it is currently written. Comments: This bill allows Pain Medicine Physicians to authorize Blue Cards, in addition to primary care providers. As such I support it, since I am a Board Certified Physician in Pain Medicine, and as a medical cannabis advocate and activist, I would like to continue this practice. The use of cannabis in the specialty of Pain Medicine fills a huge gap in care and treatments, for many chronic pain medical conditions, that otherwise do not have adequate or even minimally effective treatments. The drawback of this bill is that it limits other supportive physicians who might feel they are not legally able to authorize Blue Cards, and make it harder for patients to get them. Another problem with it is that it is unenforceable. There is no legal definition of what is a primary care provider. My opinion is that unenforceable laws should not be written into law. If one is worried about the number of medical cannabis cards being issued to people, who "may not really qualify under the law", then the solution is to set the medical standards of care and physician conduct for the medical cannabis program. This requires the Hawaii State Medical Board to become involved, by law, forcing them to deal with it. When I asked the Hawaii Medical Board to do so in 2012, and set the standards, as done by other state Medical boards, they referred me to the NED, as if law enforcement is able to set medical standards of care and conduct! They do not have the expertise to do so, and I do not recall them ever asking any physicians for an opinion. Their legislative attempted solutions seemed to rely on the criminalization of medicine. <http://hawaii.gov/dcca/pvl/boards/medical/board-meeting-minutes/2012-medical-meeting-minutes/Medical...> Hawaii Medical Board Minutes of Meeting of April 12, 2012 Page 6, e. David Barton, M.D.: Request for Official Board Position on Practice Standards Relating to Medical Marijuana. Dr. Barton is asking the Board for its official position on practice standards relating to medical marijuana. The Board determined that it is unable to take a position with respect to the State's medical marijuana program as the program does not come under the Board's jurisdiction. Additionally, the corporate practice of medicine is also not under the Board's jurisdiction, emphasizing that the Board only has jurisdiction over individual physicians. The Board advised Dr. Barton to contact the Narcotics Enforcement Division as the program comes under its jurisdiction.

_____ Well, as they stated, all physicians licensed in this state fall under their authority! However, the State Medical Cannabis program is a health program, not a law enforcement

program. I would suggest that the Legislature fix this in law, rather than limit the authorization of Blue Cards to certain physicians. My other suggestion is to set up an auditing and case review mechanism within the Dept. of Health, which can then refer cases to the State Medical Board. Comments: I am 55 yrs old and have breast cancer since 2007 which mets to my bones in 2010. Comments: There is a problematic provision in Act 178 that reads: The certifying physician shall be required to be the qualifying patient's primary care physician. This provision will prevent many qualified patients from having access to medical cannabis because some insurance providers and doctors at the VA are prevented from recommending medical marijuana. Adding "board certified pain specialist physicians" is a step in the right direction but does not go far enough. Any doctor that determines that marijuana is what is best for their patient should be able to recommend it, and legislators should not get between doctors and their patients. This bill is a step in the right direction, but must be expanded to include all licensed doctors. Currently, several groups of doctors including those at the VA and those at Kaiser, are unable to recommend medical marijuana because of organization-wide policies. If this provision is not amended it may force some patients to decide between staying with a doctor that they know and trust, and a medicine that is safe and effective. There is no reason to put sick people in that position.
