Chair Green, Vice Chair Baker, and Members of the Committee:

The Department of Public Safety **supports the intent** of Senate Bill 2579, Relating to Mental Health. This bill authorizes the Director of Budget and Finance to issue general obligation bonds for the Department of Health to develop a secure inpatient psychiatric facility.

It has become evident through public hearings that the Hawaii State Hospital (HSH) is inadequate in addressing the needs of the forensic patients that are ordered by the courts to the custody of the Department of Health. All patients at the HSH were originally charged with a criminal offense, and many have a history of violence which could pose a danger to staff and other patients. The capacity of this proposed facility is unclear; however, it should be noted that our Department shares similar concerns with

the Department of Health as we have approximately 500 severe and persistent mentally

ill inmates under our custody.

S.B. 2579 - RELATING TO MENTAL HEALTH

The Hawaii Government Employees Association strongly supports the purpose and intent of S.B. 2579. This important legislation authorizes the Director of Finance to issue general obligation bonds for the Department of Health to develop a secure inpatient psychiatric facility capable of serving the mentally ill population who require a higher level of security, and inmates and detainees who need more intensive mental health care.

Hawaii must build a secure forensic facility to address the large patient population at Hawaii State Hospital. Virtually every patient admitted now comes to the hospital by court order because they have been charged with a crime, and most have been diagnosed with severe and persistent mental illness, substance abuse, or both. In addition, a significant number of the inmates and detainees in prisons and jails have a history of violence, but also need psychiatric care.

Hawaii State Hospital is simply inadequate to treat the growing forensic population, and therefore creates serious health and safety risks to staff and patients. The current situation is unacceptable and this measure is necessary to serve and protect staff and patients. Hawaii, like many other states, should have a secure forensic facility to treat this population of patients and inmates.

We appreciate the opportunity to speak in strong support of S.B. 2579.
