# TESTIMONY OF THE OFFICE OF THE LIEUTENANT GOVERNOR TO THE SENATE COMMITTEE ON JUDICARY AND LABOR

# SENATE BILL NO. 2602

Relating to Graffiti

February 7, 2014

Senate Bill No. 2602 establishes and funds an anti-graffiti program coordinator position under the Office of the Lieutenant Governor and funds an anti-graffiti program for the use of cameras and high resolution photos to detect taggers on state property. Repeals on July 1, 2017.

The Office of the Lieutenant Governor **supports the intent** of this measure and shares the concerns over the negative impact of graffiti on our State and our local community. We are supportive of the development of a comprehensive strategy to combat the negative impact of graffiti and offer the following comments.

The Office of the Lieutenant Governor is prepared to assist the State in the development of statewide policy or plans to address the graffiti problem in Hawaii. However, the Office does not currently possess the appropriate staffing levels, funding and expertise to accomplish the intended goals under this measure, and appropriate funding and resources in FY15 and beyond would be required to fulfill the added responsibilities.
