Chair Dela Cruz, Vice-Chair Slom, and members of the committee, thank you for the opportunity to submit testimony on SB2673.

The State Procurement Office (SPO) opposes increasing the minimum procurement amount that is subject to small purchase procedures from \$25,000 to \$50,000. The increase is not necessary or supported by purchasing trends. In FY 2012 and FY 2013, ninety-six percent (96%) of purchase orders issued (based on major object codes) was less than \$25,000, while the average purchasing card transaction (pCard) changed from \$362.00 to \$376.00. Increasing the threshold promotes unfair advantage to contractors contacted for quotes versus those who are not, limits competition, and circumvents transparency in procurement.

SPO recommends leaving the maximum procurement amount that is subject to small purchase procedures at \$25,000.
