Comments to SB 2763, Relating to the Board of Education

Thank you for the opportunity to submit comments to SB 2763 which requires the Board of Education (the "*Board*") to allow public testimony on items not on a public meeting agenda if certain requirements are met.

The appointed Board since inception has placed a high priority upon stakeholder and community engagement. We spent 18 months engaging various stakeholder communities statewide in the development of the Board/Department of Education ("BOE/DOE") strategic plan. We have conducted 15 evening community meetings throughout the state which is nearly double the number of meetings required by law. Our nine volunteer Board members have visited over 200 schools and attended over 400 community stakeholder meetings throughout the state. Additionally, the Board has held 169 committee and board meetings. All meeting have been open to the public and the meeting agenda allows for public testimony at the beginning of the meetings and prior to action items on the agenda.

The board has expanded the opportunity for the public to send emails to the Board via the website as well as make phone calls to the Board office. All complaints are shared with all Board members and require a response within specific guidelines. Additionally, the BOE/DOE established an independent "hotline" for members of the public to anonymously express concerns. These are all recorded and an audit trail has been established. Also, to allow for concerns or recommendations to be expressed in private from parents, employees and general public, our Board has established "chair office hour". These times are available after every General Business Meeting (2 times per month) and typically from 4:30-5:30 p.m. which allows for parents and employees to come after work. Additionally, we have added to the permanent Board agenda, a monthly Complex Area presentation with specific metrics and performance data so that each Board meeting allocates time for our 15 community complexes to specifically discuss their individual issues with the Complex Area Superintendent ("CAS"). This allows any community member to come and testify on any subject within their school complex with the CAS and senior DOE staff as well as the Board members present.

We are in the process of reviewing all of our Board policies and are in the process of first seeking public input prior to any revisions. A good example, is a review of policy 2105 which concerns our Hawaiian Immersion program. In order to gain community input on this important subject the Board established a stakeholder working group and has conducted and attended over 40 community meetings and school visits statewide. Sex education is another example of where recently the Board dedicated the bulk of a Board meeting time to seek public input before reviewing changes to our current sex education policies. Again, a public stakeholder meeting is being formed by the DOE to ensure public input is considered.

Our DOE/BOE strategic plan specifically addresses goals and requirements for community engagement. The Superintendent's contract goals address a requirement for community engagement. Our Board fully understands we are the public's voice and therefore, have a duty to proactively seek that voice. We welcome the opportunity to improve public engagement in meaningful and productive ways.

Currently, under consideration is the televising of our Board meetings at certain times per quarter, creating public forums in which there is dialogue between the community and the Board, and increasing the number of community/complex meetings which are held within the community during the evening hours and adding a separate time for meeting staff to discuss their issues.

Thank you for the opportunity to submit testimony on this bill. The Office of Information Practices ("OIP") is commenting to express concerns regarding this bill, which would require the Board of Education ("BOE") to allow public testimony at any meeting on items that are not on its agenda but are within its authority.

Under the current Sunshine Law (Part I of HRS Chapter 92), a board is required to provide notice of its meetings and accept all written and oral testimony on every item on its agenda. If an item is not on its agenda, board members cannot discuss, deliberate or decide that item. A board may choose to have an open forum during a meeting at which members of the public can speak to any topic within the board's authority, but a board is not required to do so; and if the board does choose to allow an open forum, its members must be careful not to actually engage in any discussion of issues that are not on its agenda but are raised by the public during the open forum. Because the public has not necessarily been given notice of items that arise during the open forum,

interested persons may not be at the meeting to hear what others have to say about the issue or to present their views on the issue.

Currently, a board that draws large numbers of testifiers can control its schedule and the focus and length of its meetings by selecting the items to include on its agenda for a given meeting. For example, a board may devote a full day meeting to a single high-interest item that is expected to draw a large amount of testimony, and then schedule a shorter meeting on another date with an agenda that includes several minor issues but not the high-interest one.

This bill could make it difficult for the BOE to conduct its necessary business and to schedule what issues it will consider at which meeting, because the board would be obligated to hear <u>all</u> public testimony on <u>any</u> issue within its authority that is raised by <u>any</u> person, even if the matter was not on the properly noticed agenda. This would also mean that members of the public would be less able to rely on the BOE's agendas. For example, a person interested in curricular reform might learn after the fact that the BOE had heard extensive public testimony on adoption of a new curriculum during the open forum at a meeting that was supposed to be devoted to discussion of the unrelated issue of school bus contracting. Additionally, the BOE could draw Sunshine Law complaints alleging that it illegally considered an issue not on its agenda by hearing testimony on that issue as required by this bill, which places it between a rock and a hard place in trying to comply with the law.

Because of the potential for Sunshine Law complaints as well as the administrative challenges this bill as proposed would present, OIP recommends that the bill be amended to meet the Committee's specific concerns. For example, if this Committee wishes to place a legal obligation on the BOE to hold open public forums, it could do so in a more limited manner, such as requiring that at least one

such forum be held during a set period of time, rather than turning every meeting into an open forum as this bill does in its current form.

Chair Tokuda, Vice-Chair Kidani and Committee Members:

The League of Women Voters of Hawaii supports the intent of SB 2763 that would require the Board to have an 'open forum' on its meeting agenda. We suggest an amendment to the bill.

The League supports the public's rights and interest concerning the administration, policy setting and budget making for our statewide school system. We believe the proposed measure is consistent with Chapter 92 Section 302A-124 HRS and the Board's By-Laws.

At the present time, the public is permitted to testify at full Board of Education meetings, but only on items that already appear on the previously set agenda. We request that SB2763 be amended to require that every meeting of the full Board of Education have an agenda item titled 'Open Forum' or 'Community Items,' for the purpose of allowing the public to submit proposals for **future** agenda items. This would permit greater transparency because minutes of the Board meeting would then include the proposed agenda items submitted by the public to the 'Open Forum' or 'Community Items' section of the Board meeting. At a subsequent Board meeting the full Board could then take action on any open 'Open Forum or 'Community Items.' While this would not guarantee inclusion on the agenda of the items proposed by the public under the 'Open Forum' or 'Community Items' area, it would create a venue for the public to present suggestions of items for discussion.

Senator Tokuda and Members of the Committee:

I am Marcia Linville, speaking in support of Senate Bill 2763.

I served as librarian for over 30 years in federal, state, city and special libraries, as HGEA Agency Council Head, Unit 13, DOE, for almost 20 years, as President of the Librarians Association of Hawaii for two terms and as Childrens Section Head for the Hawaii Librarians Association. I have also served as legislative liaison for the Democratic Party, for HLA and for LAH.

The opportunity for the public to bring to the attention of the Board of Education matters of public concern, has been for over 30 years, one of the most effective ways to inform the Board of Education of problems within the schools or the system of which they may have been unaware. This period for public input was eliminated when the appointed Board decided to limit public testimony to only those matters appearing on the agenda. When one petitioner asked how she could get something on the agenda, she was told "You can't".

It is my belief that the Board, based on its experience, has taken a business model as it working paradigm, seeing the Superintendent as the CEO, the CAS as middle management, the teachers as retailers and the students as consumers. But this model has failed to recognize the fact that Hawaii's people as a whole are the customers who are affected by public education. The Board is, in effect, cutting off consumer input, usually believed to be a necessary part of any successful business. The Board has recently acerbated this obstacle to public input by proposing to limit the general business meeting to only one a month. Granted that this is a volunteer, unpaid board, which has been successful in eliminating many unnecessary expenses, it does not seem a reasonable perception that eliminating opportunities for public input on areas of concern is eliminating an unnecessary expense.
