In consideration of SENATE BILL 3003, SENATE DRAFT 1 RELATING TO LAND

Senate Bill 3003, Senate Draft 1 proposes to create a separate County of Niihau which would include Niihau, Lehua and Kaula, to be managed by the Department of Land and Natural Resources (Department). This measure also proposes that the ability to tax real property on Niihau remain within the jurisdiction of County of Kauai, and the officer of the county will be the sheriff, who will be a resident of Niihau and whose salary will be paid by the Department. The Department has concerns about this measure and offers the following comments.

In recent months, the issue of natural resources management relating to Niihau has been of concern to the Legislature as well as the Department. As a result, several legislation have been introduced and the Department continues to develop rules itself regarding natural resources management for Niihau.

Given these developments, the Department believes that establishing Niihau as a separate county legislatively should not be undertaken at this time until the matter is initially and further discussed with the County of the Kauai, the Department, and the people of Niihau. This is a serious proposal that needs adequate consultation among relevant governmental agencies and stakeholders.
