Dear Chair Ige, Vice-Chair Kidani, and members of the Committee.

I am writing to you about SB3035, the proposal to fund and direct DOT to realign Kamehameha Hwy near Laniakea on the North Shore. I strongly support this bill and request that you pass it so that the Senate can consider it.

My reasons for supporting this bill are (a) that this area desperately needs traffic mitigation because the traffic congestion there is a serious problem both for local residents and for other residents of the island, and visitors, who wish to visit and enjoy much of the North Shore and (b) that the DOT "short term" solution (barricading off parking) is not only an aesthetic travesty of a beautiful beach area, but is highly likely to be found inadequate when Summer time leisure activities and tourist traffic returns in full force.

The original draft of this bill included planning for Chun's Reef and proposed that DLNR be the project lead, so that whatever is done manages the entire area, including creating park facilities for visitors. If let solely to DOT, the result is likely to be a narrow "transport only" solution, which would be greatly less than what could be done in this area. I would support the lead role in this activity being restored to DLNR.

Comments: Dear Chair Ige, Vice-Chair Kidani, and members of the committee, I write in STRONG SUPPORT of SB3035, which requires the State Department of Transportation (DOT) to realign Kamehameha Highway mauka at Laniakea beach on the North Shore. I recommend two key amendments to return to the original intent of the bill: (1) broaden the scope to include Chun's Reef as part of the realignment project, (2) expressly include the State Department of Land & Natural Resources (DLNR) as a co-lead agency partner with DOT and require the establishment of a State Wayside Park at Laniakea and Chun's. DLNR's participation is vital - this is not just a highway project. This measure is a wise investment of state resources in ensuring the long-term protection of an at-risk portion of the two-lane Kamehameha Highway that is vital to the entire island. Climate resiliency and resource protection can go hand in hand with managing traffic and people, as well as the green sea turtle habitat. As the Feb 18 2014 Star-Advertiser Editorial stated (referring to SB3035 and SB3036): "These bills should pass, sending a clear message that further delay is simply intolerable. Government may drag its heels on a highway project, but erosion won't wait forever. The end result we don't want is for the sea to claim Kamehameha Highway." Aloha Committee Members,

I would like to voice my strong support for SB 3035. The north shore of Oahu is in need of a transportation overhaul as the addition of people, coupled with an increase in sea level and storm surge is going to take a major toll on this region in the near future. Laniakea is already suffering from tourist traffic do to the inadequate road system in the area and the recent barricades by Department of Transportation are a poorly planned band-aid approach to the issue. While not only reducing beach access for the public, the issue of parking has just been pushed farther down the road and crossing by pedestrians is now in even more precarious spots.

The bypass road and wayside park is a much more complete solution to the issues that we are facing on the north shore. By creating a sustainably built park on the Makai side of the new highway we can efficiently reduce illegal crossing which halts traffic. For issues of sustainability and productive planning, I highly encourage that DLNR is put back into this bill as part of the managers of the plan.
