In consideration of SENATE BILL 3035 RELATING TO CONSERVATION

Senate Bill 3035 proposes to authorize the issuance of general obligation bonds and appropriates funds for the planning and construction of the Laniakea wayside park on the north shore of Oahu. The Department of Land and Natural Resources (Department) supports the intent of the bill, specifically in order to enhance the protection of the Hawaii green sea turtle, but has grave reservations concerning the sequence of land dispositions necessary, prior to establishing the area as a wayside park with the necessary public management infrastructure.

The creation of a wayside park at Laniakea would better serve the community and the visitor industry; however, the impact of that action upon the protection of the Hawaii green sea turtle must also be evaluated. Creation of a park could increase human interaction with this species.

An additional concern for the Department's Division of State Parks (Division) is the number of active projects in progress. In addition to management of existing parks, sites, reserves and monuments, the Division is currently tasked with the development of Central Maui Regional Park (Wai'ale) on Maui; has five master plans in various stages of completion; and has been engaged in the possible acquisition of Lipoa Point on Maui. There are also several key parks that are ready to initiate recreational enhancements and income production to support state-wide Division operating needs. Adding yet another new feature with its appurtenant development process jeopardizes the timely success of pre-existing projects.

Of paramount concern in the development of Laniakea is the need for the Department of Transportation to both confirm the ability to re-align the State highway at this location, and then execute it. This involves the consent of the adjacent landowner, Kamehameha Schools. Absent this action, the Department of Land and Natural Resources has determined that the bill as written is premature.

After the actions associated with roadway alignment and disposition are confirmed and initiated, there could be meaningful discussion between the Department, the Fish and Wildlife Service, and the City and County of Honolulu on the best management policy and infrastructure to enhance protection of the Hawaii green sea turtle and service the public in its desire to view and experience this popular species.

Accordingly, the Department recommends a deferral of this measure as written -- or passage with new language that places the roadway re-alignment process as the priority action to fulfill the intent of the bill.

HEARING OF FEBRUARY 10, 2014 TESTIMONY IN SUPPORT OF SB 3035 RELATING TO CONSERVATION

Aloha Chairs Solomon and English, Vice-Chairs Galuteria and Dela Cruz and Members of the Committees,

Thank you for the opportunity to express my support for SB 3035 the issuance of general obligation bonds and appropriation of funds for the planning and construction of the Laniakea wayside park on the North Shore of Oahu. The Hawaii Tourism Authority reports 5,100,169 people visited Oahu last year, up 4 percent from 2012 and up 15.9 percent from 2011. Furthermore, the average number of visitors on Oahu on any given day in 2012 was 97,989 people, a number that has continued to grow each year.

A study done by the North Shore Chamber of Commerce in 2006 indicated that North Shore permanent residents share their area with an estimated average of 6,731 visitors on any given day. In addition, surveys done by the State Department of Business Economic Development and Tourism show that in 2003 and 2005, 51 percent of all visitors to Oahu visit the North Shore which translates to 2,423,446 visitors per year, and that this dramatically increases the localized area population by 43 percent.

The tourism population will likely continue to have an impact on the Hawaiian green sea turtle population, especially on the North Shore of Oahu. Nowhere is this impact more obvious than Laniakea beach, demonstrating the need for more conservation efforts. The construction of a wayside park would provide a long-term solution to the traffic problems and other impacts of tourists at Laniakea beach. For all of the reasons stated above, I strongly support SB 3035.

Dear Chair Solomon, Chair English, Vice-Chair Galuteria, Vice-Chair DeLa Cruz, and Committee Members:

I write in **STRONG SUPORT OF SB3035** introduced by Senator Clayton Hee. This bill will establish a State wayside park at Laniakea and Chun's beaches on the North Shore of Oahu. The bill proposes to put the Department of Land & Natural Resources (DLNR) in the lead on the planning and supplemental land acquisitions necessary to create a new "wayside" park in collaboration with the community and surrounding landowners -- particularly Kamehameha Schools, the State Department of Transportation (DOT), and the City and County of Honolulu.

For too long, the chaotic over-use of this stretch of highway near Laniakea Beach Park by unregulated visitor traffic and pedestrians haphazardly crossing Kamehameha highway has been a severe safety problem for residents and visitors, jammed up the highway for miles on virtually every weekend and now on weekdays, and created havoc for the green sea turtles for which this beach is essential resting and foraging habitat. For over ten years, the community has patiently waited for a permanent solution. None has appeared despite a huge investment of community and agency time, money, goodwill, and energy. The new "temporary concrete traffic barriers" installed by DOT at the site are an embarrassing eyesore and certainly not a long-term solution.

The realignment task force led by DOT has languished for years and narrowly focused on the highway, without adequate consideration for the high natural resources, scenic, cultural, and recreational values of this area. Ten years ago, the City set aside several acres of land at Laniakea and Chun's for beach parks (which can provide critical site anchors for an overlay of a state wayside park) but the City's efforts to create these two support parks has also stalled. Kamehameha Schools (KS) has indicated its support for this new "state wayside park" approach. The solution for this area must be a comprehensive state-city-KS-community solution – it can build on these prior efforts but should solve the problems in both adjacent areas with a single solution and must consider the impacts of climate change and beach erosion, already a significant problem in this area for both the highway and for beach users.

A state wayside park (such as the state has created at Nu'uanu Pali, La'ie Point, and Makapu'u) will be a fresh integrated approach, changing the focus from just "moving the highway mauka" (which seems to be an area of near-universal agreement) to a comprehensive solution that appropriately protects the high natural resource and scenic values of this area. A well-designed wayside park can provide a safe, controlled, and educational experience for visitors briefly passing through the North Shore, be a model for how state beach parks can be resilient and adaptive to climate change, and also give highest priority for local uses of the beaches of this area as well protecting turtle habitat.

Although the specific design is "to be determined," the broad inter-agency and collaborative approach of the bill is critical to a successful solution for the severe traffic mismanagement problem that adversely impacts anyone going "circle island" as well as those who live on the North Shore.

Comments: Esteemed Senators, Mahalo for allowing this testimony to be submitted in favor of this bill WITH AMENDMENTS. I completely concur there is an overwhelming number of people who frequently Laniakea since it is published on all the TOURIST maps as a place where Hawai'ian Green Sea Turtles can be seen. The tourist industry is a major economic driver for the islands, but there is little governance of "how" the tour companies operate when endangered species are concerned. I do believe setting aside land to provide a space for honu basking is very appropriate, as is the educational signage regarding the turtle habitat. My suggested amendment is incorporating more than "remote security" at this site. Currently, a small group of volunteers attempt to staff the area to provide education and encourage respectful viewing of the turtle feeding and basking area. They are not DLNR officers, so their ability to protect the honu from unruly persons is absent. The result is frustration, arguments, and altercations as the Honu guardian volunteers attempt to reason with tourists who think it is perfectly ok to allow their children to "climb on the turtle for a cute picture" or adults who enter the water to grab on to a feeding honu for a "free swim with the turtles". I encourage an amendment to this bill to include a fee for any tour bus or tour operator who either advertises Laniakea as a stop or actually stops at the wayside park to fund positions for a DLNR officer to be stationed during daylight hours to ensure the safety of those entering the wayside park and to protect the turtle habitat. Remote security could be employed at night. Mahalo for the opportunity to submit testimony in SUPPORT WITH AMENDMENT as stated above.
